(A) A point of contact will be clearly posted and maintained on a highly visible area of the building at all times.

If, at any time the points of contact or the preferred method of contact changes for any reason, the community council executive board will be notified immediately.

- (C) Secret Garden Cannabis shall maintain records of refusals for service at the establishment and submit monthly reports to the council for public review. Scheduled outreach to the surrounding community within 500 feet of our proposed location will take place at least once a year and include a mailed letter detailing our annual plan, including contact information for any feedback or questions from our neighbors.
- (D) In the case that there is a dispute regarding Secret Garden Cannabis' business practices or an occurrence taking place on Secret Garden Cannabis' property by a local business, neighbor, the community council itself, or Secret Garden Cannabis, we will identify, discuss, and attempt to resolve that dispute.

If unable to resolve the dispute directly with the complainant, Secret Garden Cannabis will bring the matter to the Fairview Community Council to attempt a resolution. The Council may choose to refer the matter to the AD-Hoc Marijuana Committee, or to the regularly scheduled Executive Board meeting.

The dispute process, including all meetings and official discussions will be documented and kept on file for a period of 5 years.

(E) A representative from Secret Garden Cannabis shall attend a Fairview Community Council meeting at minimum once every three months. Individuals who are formally allowed to speak for Secret Garden Cannabis at the community council meetings are as follows:

If the individuals who are formally allowed to speak for Secret Garden Cannabis changes, the community council executive board will be notified immediately.
(F) The Owner of Secret Garden Cannabis, James M. Thornton or his representative will attend at least four general membership community council meetings per year.

The parties have executed this Agreement as of the effective date. The Agreement may be updated from time to time with the concurrence of both parties, and shall remain in effect as long as the Marijuana Business is licensed to operate at the proposed location.
