**2. Lake Hood Seaplane Base Frozen Lakes:** Winter operations are in effect, and we are requesting everyone’s help to remind others to please stay off the ice. **3. General Election Voting:** Alaska voters can cast in-person absentee ballots from 7:00 a.m. to 8 p.m., November 3<sup>rd</sup>, at ANC. Polling is located on Level 0 across from the lost and found. 30 minutes of free parking is available in the parking garage and short-term parking lot.

**4. Cellphone Parking Lot:** There is a free cellphone lot available for drivers to wait until arriving passengers have deplaned, collected luggage and called to be picked up. The cellphone lot is in a designated area of the DOT&PF Central Region Headquarters parking lot - just two minutes away from both the South and North Terminals.
