- o Overview: \$549.5 M general fund budget
 - Addresses general fund deficit
 - Prioritizes PTR and educational programs (ie Ignite)
 - Focuses resources on SB Goals (reading, math, CCL)
 - Redesigns education to focus on learning gaps
- olmportant points:
 - Flat funding of BSA since FY 2017, coupled with ongoing inflationary drivers, means that we currently have a deficit and that we have a projected 67 m fiscal cliff in FY 25

- For FY 23 (next year), on one hand, revenue from local property taxes and the state (foundation funding) are both decreasing next year (about 15 m total) due to enrollment (so Gen Fund budget is 2.8% smaller than last year's)
- BUT we have about 91 m left in Fed relief funds that expire in Sept 2024 oSO this budget reflects a federal band-aid:
 - bulk of ESSER III federal relief dollars going to retaining PTR 56.2 m
 - This is 10 PTR above what current BSA would allow
 - Focus on student learning loss includes summer school, reading interventionists and initiatives
 - Includes Air quality and intercom improvement work at 24 and 16 schools, respectively, over next two years

How did we get this proposal? ANNUALLY,

A) ASD evaluates its buildings c/o:

- 1) Facility Condition Indices (FCIs) The FCI shows deficiencies in building systems such as roofs, boilers, windows and similar items. This may be thought of as the physical condition of the building and its components.
- 2) Educational Adequacy Assessments (EAs). EAs show deficiencies in instructional capabilities such as teaching spaces, special purpose areas and other spaces.

*In Bond years, now every two years, ASD's Capital Improvement Advisory Committee (CIAC) evaluates the information provided by ASD staff and develops a recommendation for the superintendent and school board. CIAC is 12-15 community members representing a range of geographic, professional and community perspectives.

In fall, Admin presents a proposed Bond Package to Board; Board has some time to consider that recommendation, take & respond to public input, and approve final bond package. The package is then sent to Assembly, which cannot edit the proposal, but <u>can</u> vote whether or not to approve it.
