## **Resolution Regarding Public Land Use and Enforcement**

The draft resolution comes from the District 1 Leadership Team, comprised of community council presidents, vice presidents and community leaders from each of the neighborhoods that are in District 1. We join together in this to demonstrate that it is more than just our neighborhood who shares these concerns. We are unified across community councils, and we are hoping to use that "louder" voice to advocate for improved management of a very difficult situation. The resolution, in short, asks for four things: (1) that the muni stop enabling negative behaviors that violate Title 8 and 15 of municipal code, (2) that the muni develop policies that will allow for more effective management of public land and spaces in District 1, (3) that action be taken to mitigate public nuisance scenarios before the closure of emergency cold weather shelters and (4) that the muni conduct due diligence on the option of dispersed and well managed sanctioned camps (as opposed to the ongoing abuse of public land).

## **Free Health Clinic**

There is a free Health Clinic at Begich Middle School April 20-21. It is a completely free event, granted by the Anchorage Health Dept, the Alaska State Dept of Public Health, and the Public Health Services Commission Corps, providing free vision, dental and medical care, along with free labwork, free glasses, and more.
