**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS
PROTEST REGARDING A TRANSFER OF OWNERSHIP OF A PACKAGE STORE
LIQUOR LICENSE #2614 FOR AK, INC dba 2 GO MART #10, LOCATED AT 500
HOLLYWOOD DRIVE, AND AUTHORIZING THE MUNICIPAL CLERK TO TAKE CERTAIN
ACTION.**

WHEREAS, AK, Inc. has made an application with the Alcoholic Beverage Control (ABC) Board and has paid the required fee for a Transfer of Ownership for a Package Store Liquor License #2614 to be used for 2 Go Mart #10, located at 500 Hollywood Drive, Anchorage, Alaska; and

WHEREAS, the Assembly must enter any protest to the ABC Board within 60 days following receipt of the application; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on February 11, 2015 and has determined that the last day for the Assembly to file a protest is April 12, 2015 and

WHEREAS, the Assembly Meeting on March 24, 2015 is the last scheduled regular meeting of the Anchorage Assembly prior to the expiration of the protest period; and

WHEREAS, the Municipal Clerk reports the following status concerning this location:

1. No ABC Board violations and/or incidents that would lead to an ABC Board violation;
2. There are taxes owing to the Municipality of Anchorage in the amount of **\$4,065.67**;
3. Anchorage Fire Department, Municipal Health & Human Services, and Municipal Building Safety approvals **have** been received;
4. Conditional Use Permit, required by AMC 21.50.160, **has been approved**;

1 WHEREAS, protest by the Assembly is in order pending Municipal Clerk confirmation
2 that outstanding items required for this location have been completed;

4 NOW, THEREFORE, THE ANCHORAGE ASSEMBLY RESOLVES:

6 Section 1. The Anchorage Assembly hereby enters its **PROTEST** for a Transfer of
7 Ownership of a Package Store Liquor License #2614 until these
8 conditions are met:

- 10 • Taxes owing to the Municipality of Anchorage in the amount of
11 \$4,065.67 are paid in full.

13 Section 2. A copy of this Assembly Resolution may be presented to the Alcoholic
14 Beverage Control Board as proof that the Anchorage Assembly, as the
15 local governing body, has stated its protest in order to allow the Director
16 of the Alcoholic Beverage Control Board to hold processing of Package
17 Store Liquor License #2614 under local protest, until receipt by the
18 Director of confirmation from the Municipal Clerk that the conditions in
19 Section 1 have been met, and this protest is lifted as authorized by this
20 Assembly Resolution.

22 Section 3. The Anchorage Assembly hereby authorizes the Municipal Clerk, upon
23 Municipal Clerk confirmation that all conditions in Section 1 have been
24 met, to provide written notification to the Alcoholic Beverage Control
25 Board that this protest by the Anchorage Assembly is lifted, without
26 further action by the Assembly.
