Legislative report:

Senator Natasha von Imhof via cellphone

- In depth discussion of SB26
- No senate sponsored income tax bill
- \$600 – 700 million dollar budget gap that can be funded by CBR for 10 years
- Health services cost not going down

Tony Hoffman presentation on zoning permit for 92nd and C Street rezone

- This application is it incorporate a small piece of R-2M zoning into the larger I-2 zoning
- for the rest of the property. This was caused by old zoning actions and failed recordkeeping.
- Discussion followed from a large group of residents from across 92nd Ave in opposition to the permit. It was determined that this group of residents actually reside in the Taku Campbell Council area. The council dividing line is 92nd Ave in that area.
- Discussion was allowed to continue but President Hoffman had to remind the group on several occasions that this was not an application for planed use or the correct time to protest the "housekeeping" rezoning. Their concerns should be directed to the Planning and Zoning commission of the MOA though their council.
Discussion also indicated that 92nd Ave maybe classified as a class 2 roadway but is not Built to that standard. Residents were concerned of the expected heavy track traffic Going into and out of the entrance on 92nd Ave.

South Anchorage Sports Park Update

- The Resolution from 2/2/3/2017 meeting was sent to the MOA parks and was accepted. The park hours will be changing. The community patrol will be issued keys to lock the gate once new signs are in place showing the new hours and who to call when locked in. The number is to APD who will respond and have a "little chat" with those found inside the park afterhours.
