Minutes from 17 May 2017; Moved by John, Roselynn 2<sup>nd</sup>; approved.  
Info on Neighborhood watch and we can get an officer to come to the meeting and talk about it. It is a street by street program.

Bus service changes happen on 23 October. Question if that will affect snow plowing. It is still a school bus route. Johns, Oceanview are both state maintained.

Treas report: Currently \$1752.37 up 0.27 since we last met. As of end of August.

**John Weddleton:** Anchorage Assembly. Community Council website shows our meeting at different times. • Mold in hotels is a new issue for Assembly action.

- Well and septic rules have been re-written.
- Should there be rules for on-site consumption of marijuana? Public meeting will be held on responses
- Campers [homeless?] in parks.
- New legislation to make joy-riding a more significant crime.
- New way of determining how to assess “junk yard” residential properties.
- Speeding in neighborhoods is a major complaint. AMATS is beginning a new process to evaluate and plan.

**Chuck Kopp:** Representative. Mayor should make a statement of citizen’s rights. Public Safety is a huge concern and some tenets of SB91 are going to be changed to make the bill more effective. Idea is to make certain criminals go to jail more quickly to make a change to the criminal wave of that one person. Also to incarcerate between conviction and prison sentence.

SB54 is the new bill to replace SB91. It will put some bite back in, but will not solve all the problems. It’s more of an immediate consequence for the criminals. He can arrange for a state prosecutor to come to meeting to give advice on how to protect personal property.

Speeding and streets – prioritize. Ellen, Helen and Mary streets. Traffic calming. High speeding. Also Klatt, but difficult to put speed bumps on Klatt. Others will need to be upgraded to be able to accept speed bumps.

Chuck is part of a committee looking at a new way for education funding. Tribal schools for some areas. Compact with the state to decrease state input for education in those areas.

**Steve** asked if Chuck will arrange for a prosecutor to be at the next meeting. Also requests Katie to ask the mayor to have a city prosecutor at the next meeting.

**Katie Dougherty:** – Mayor's office; Great to see so many folks at the meeting this evening. Mayor's primary priority is public safety. She'll ask the correct person to attend next meeting with rights of property owners to protect. Muni and state laws may have different directions.

**Suzanne LaFrance,** Anchorage Assenbly

- Land use plan supplements the 2020 plan with more neighborhood and district elements. Adopted last night.
- Budget cycle for 2018. Happening right now. Work session on Friday – open to public. First public hearing 24 October. There will be reductions. Positions will be eliminated.
- Well and septic was introduced last night. John pulled to make it on the 2<sup>nd</sup> meeting in October to allow citizens more time to consider.

Guest: **Alaska Sand and Gravel.** Ryan Morman and Ryan \_\_\_\_\_. Trying not to bombard Klatt Road with truck traffic. Access to and from their facility is paramount. Property where they have a lease to route some of their traffic is for sale. Lease may no longer allow the trucks to use that route. They want to avoid using Klatt road to go west on Minnesota.

R&M Consultants looked at a way to use the existing C / Minnesota roundabout as a two way from Lang Street to C Street roundabout. This would close the existing on-ramp to O'Malley going east and route it further east.

**Steve:** Traffic calming priority: Handout has only the Oceanview and Old Seward streets that are graded and ranked for priority. We're asked to rank them for our area. We need to have a resolution to ask the Muni to use our priorities. Fire traffic is the most affected by traffic calming measures. How do we calm while offering emergency response well? These are Muni roads, so state maintained roads are not included. Vote on this next month.

Park Foundation grant coming for Hamilton Park – Elmhurst and Karen Street areas. Info from people in that area is requested. Blake Adolfae is the contact. 2018 request for 2019 construction.

Wildflower – grants group – for teachers etc. has a scholarship program for up to \$2000. Goal is to encourage botanical education. Due 1 November 2017
