Scenic Foothills Community Council

The May 4 Council meeting has several presentations that are important to all of us.

Municipal Code enforcement:

- Spring is the time of year when all of us are coming out from under the cover of winter, with reminders of what was left behind last Fall or what someone has tried to forget. Some of us may have neighbors that allow trash to accumulate, park cars illegally on the property, or maybe add a building or new fence in an improper location.
- Whatever the possible complaint, at the May Council meeting we will have a representative of the Municipality explain what constitutes a code violation, how to file a formal complaint, and how this is investigated. The Municipality wants to hear about our problem areas.
- **Recreational opportunities:** Learn about various recreational opportunities we have nearby for hiking, biking and other recreation. Come share your experiences or learn about something new.
- Did you know it is possible to legally access JBER for your outdoor recreation? The iSportsman program will be described for you, telling you how to sign up and how to learn what areas are open for recreation when you intend to go.
- SFCC Board election The annual election will be held for members of the Council's Board.
- **Neighborhood concerns:** We rely on your input to help design our future meeting agendas. Please attend this meeting to help us, through our discussions, make Anchorage a better place to live.

Nextdoor.com is a free and private social network just for Scenic Foothills neighbors. On Nextdoor, neighbors share crime and safety concerns, local events, recommendations, items for sale/free, information on missing pets, ideas about how to make our neighborhood better and safer. In January 2015, Scenic Foothills Community Council board members rather cautiously began an evaluation of Nextdoor.com as a way of interacting with more of our neighbors – the folks next door. We now encourage your participation. Several smaller neighborhoods were combined into one Scenic Foothills neighborhood along our community council boundaries. Nextdoor.ScenicFoothills has since grown to more than 1,080 Nextdoor neighbors (25% of households), far more than the number on the SFCC e-mail list and with less than 25% overlap.
Many of our Nextdoor neighbors participated in the Capital Improvements Project survey last spring and many more have been active on park safety, bike trails, bear awareness and other neighborhood issues.



Nextdoor.com is an effective way to interact with more people who are actively involved in our neighborhood issues. If you are not already participating, we suggest you consider becoming a Nextdoor neighbor as a way of keeping up on neighborhood concerns, whether or not you choose to attend the SFCC meetings.
Please join us on Nextdoor Scenic Foothills to build ourselves a better neighborhood. We also suggest you consider turning off some of the e-mail and notifications options, especially if you are using a smartphone.

Our part of town—from the Tudor-Muldoon curve to the swerve onto the Glenn Highway—is named after Anchorage pioneer homesteader **Arnold L. Muldoon**. He put up a log cabin among the spruce trees near Northern Lights Boulevard in the winter of 1940. He packed the materials out on his back, along a muddy trail that became Muldoon Road. Arnold L. Muldoon Park, named in his honor, preserves a portion of his original homestead.
