## At last—32nd Avenue Upgrade, Muldoon Road to Brookridge Drive, is ready to go!

Street widening construction is to begin mid-July 2012, with re-paving completed before winter. Cherry Street drainage repairs and re-paving between 32nd and 36th Avenues is to be done during the summer of 2013.

Our part of town—from the Tudor-Muldoon curve to the swerve onto the Glenn Highway—is named after Anchorage pioneer homesteader Arnold L. Muldoon. He put up a log cabin among the spruce trees near Northern Lights Boulevard in the winter of 1940. He packed the materials out on his back, along a muddy trail that became Muldoon Road. Arnold L. Muldoon Park, named in his honor, preserves a portion of his original homestead.

**Woodcutting & Wildfires Mitigation, Arnold L. Muldoon Park:** volunteers meet 5-8 p.m. Mondays and Wednesdays at 32nd Avenue and Creekside Drive to remove dead trees and excess fuels from the forest. Free firewood is stacked at trailheads.
