



Our part of town—from the Tudor-Muldoon curve to the swerve onto the Glenn Highway—is named after Anchorage pioneer homesteader Arnold L. Muldoon. He put up a log cabin among the spruce trees near Northern Lights Boulevard in the winter of 1940. He packed the materials out on his back, along a muddy trail that became Muldoon Road. Arnold L. Muldoon Park, named in his honor, preserves a portion of his original homestead. In 2010, “Arnie’s Army” volunteered to Spruce Up Muldoon Road. See results below.

“Arnie’s Army” volunteers cut weeds and brush that had invaded the trees and shrubs planted along Muldoon Road. Wayland Baptist University staff and students participated and also cleaned roadside litter from DeBarr Road to Patterson Street on the Tudor-Muldoon curve. Parks and Recreation staff provided guidance and support, including tools, work gloves and reflective vests. About 60 volunteers turned out. To celebrate their 25th anniversary in Anchorage, Wayland Baptist University hosted a picnic hot dog barbecue in their parking lot after the work was done.
