

BY-LAWS AMENDMENTS

Over the past several months, various proposed amendments to our by-laws have been discussed at Council Meetings. Listed below are the final versions of the proposed amendments to the Fairview Community Council By-Laws, as adopted February 11, 1993, and amended on March 11, 1993. These proposed amendments will be discussed and voted upon by the Membership during the August 12, 2004 General Membership Meeting. The amendments, and reasoning behind them are listed below. ARTICLE II BOUNDARIES

1 Changes the description to match the new boundaries implemented in July 2003.

The Fairview Community Council shall encompass the area outlined in Map 5b, Northwest Anchorage Bowl: East Downtown Vicinity Community Council Districts, as defined by the Anchorage Assembly in July 2003.

2 Inserts a word left out when the by-laws were written

ARTICLE III DEFINITION

(Municipal Code and Guidelines)

- Gives the Council the option to recruit members outside of monthly meetings.
- D. To become a member of the Council one must register at a regular monthly meeting or Council sponsored function.
- 4 Ties in with the above change.
- E. A new member is eligible to vote at the regular meeting next following the meeting or Council function at which he or she registered.
- Increases the minimum required meetings from 4 to 8.
- A. There shall be a minimum of eight (8) general membership meetings per year. Annual election of officers shall take place at the March General Membership Meeting.
- Writes into the by-laws something that the Council has done for many years, making it official, and above challenge.
- H. A Resolution brought before the Council shall be voted on no earlier than the next regularly scheduled General Membership Meeting following the regularly scheduled General Membership Meeting at which the resolution is introduced and read.
- The Council has problems getting people to run for office. The annual election by the Membership is a form of term limits.
- B. There shall be no term limits for Council officers.
- **8** Decreases the required Board Meetings from 12 to 10, giving the E Board some flexibility.
- 2. The Executive Board shall meet at least ten (10) times a year.
- 9 Eliminates the need to pay an accountant, and substitutes "a person approved by the Membership." Accountants cost MONEY.
- C. A financial report signed by the Treasurer and the President and a person approved by the Membership showing all receipts and expenditures shall be made yearly to the Council prior to the election of new officers.
