

CAMPBELL PARK COMMUNITY COUNCIL
MINUTES OF MEETING ON APRIL 13, 2006

Meeting was called to order at 7:30 by David Cummings, Vice Chairman. 13 people were in attendance. President Dave Traver was excused from the meeting as he was out of town.

Minutes were reviewed from the March 2006 meeting and approved.

Cindi Stanton, police officer, indicated that the Deputy Chief wanted to let us know they are contacting a lot of body armor and weapons in the department. Reminded us not to leave valuable in cars now that spring has arrived as there is an increase in car break ins.

Dick Traini requested that Cindi find out what needs to be done to get laws in place to compel witnesses to talk. Requested that the Police Department check speed limit on the round-a-bout.

Cindi indicated that we were to call APD dispatch on any found bikes.

Assembly Report:

Dick Traini indicated that Superintendent Carol Comeau wants a special election for bonds. She was told no. Anchorage School District still has \$48 million in unsold bonds.

Tuesday issues: Bar and church cannot be within 200 feet of each other. An owner had requested a liquor license next door to the Russian Orthodox Church. Will readdress on April 18.

Ordinance brought forth to change city laws to reflect state laws which cannot restrict anyone from having a gun on school or public property.

Bonds failed for school district and 4th Avenue Theater. The Assembly would like more transparency in where the money goes for the school district regarding law suits.

Taking testimony to change municipal sign ordinance.

Information was handed out regarding Parks Department. Shawna Popovici from Parks indicated they were doing a lot of construction in the parks. Campbell and Bancroft Parks will both be getting new amenities. Overlook to Campbell Creek is a sound structure.

Sandi Traini is still on Parks & Recreation Board so let Sandi or Shawna know what we want done. Trailhead is still a target for crimes. Camp Registration starts on April 18 at Spenard Recreation Center.

Mary Ellen Tuttle from Dowl Engineers reported on 48th ave extension where Bragraw ends and the connection into Boniface Parkway. Scoping Meeting May 4th at Permitting Building on Bragraw at 6:30 pm. Design funding is in place with Construction in 2007-08. AWW water main in corridor will be included. They will look at how trails are connected. There are some wetlands involved.

Bill Strickler from Dowl Engineers reported on Tudor and Lake Otis. They are still working on and gathering information, the scoping meeting will be on May 15 at Wendler Middle School.
