## Road Construction Updates

- o Bob Coghill, DOWL Engineers. Has held three committee meetings with the NECC to discuss traffic calming measures. The public meeting will be July 18<sup>th</sup> at Muldoon Elementary School. Bob reviewed the proposed traffic calming measures shown on the planning maps. There was some discussion on the road "extensions" that were on the traffic calming map. There are currently no plans for those extensions, but they were put on the map at MOA Planning's request, as the extensions are under consideration for future projects. #### Greenhouse Property Update – Don Smith

Volunteers of America is trying to buy the property but there are legal issues involved with the property (the Federal Government has seized the property). The MOA Assembly has also authorized the purchase of the property (10 to 0) for a park. Don has been working with the Federal Government, the MOA and Volunteers of America in an effort to liquidate the land, and get it sold to VOA and the MOA.

# Anchorage School District

- Ainslie Phillips reported on the Muldoon Area Middle School tree restoration. The MOA has filed a notice of violation with ASD for overclearing of the school site along the road, and within the creek buffers. Next restoration committee meeting is June 16<sup>th</sup> at 1:00 pm at the school site.

#### **BUSINESS:**

- (1) Cook Inlet Housing Update, Jeff Judd of Cook Inlet, & Harvey Prickett, Dean Architects
  - Not present.
- (2) Clark Middle School Design Update, Mike Carlson, McCool Carlson Green, Architects
  - The design team for the school project has worked through a number of options and variations, and is the process of pulling together a draft plan for review and finalization by ASD.
  - The only portions of the existing building that will be saved are the library and adjacent portions from the 1994 construction. (Dean: He misspoke at the meeting I just checked my notebook on all the schools additions and it was in 1994 I had just gotten on the Board. I think we should put in the correct information.) The existing classrooms will be torn down and rebuilt.
  - The school, as proposed will be three stories, with one floor each for 6, 7, and 8<sup>th</sup> grades. The three story configuration minimizes the building footprint, to maximize use of the site, and takes advantage of the sloping site.
  - The site plan will separate private vehicles from school buses. The sports fields will be reorganized, and additional fields added.

# (3) NECC CIP List Update, Ainslie Phillips

- As has been our standard procedure, the NECC capital improvements (CIP) list was reviewed and approved by the NECC in February of this year, and submitted to the MOA and the State that same month.
- However, MOA revised their process and asked that the community councils sort and prioritize the CIP list by municipal department and to submit them by June 23rd. This is somewhat problematic, as not all of our CIP items logically fall into the departments the MOA has asked us to use. Also, the MOA version of our CIP list uses different names for a number of the projects. Furthermore, there was a question as to whether the CIP items where to be prioritized by department, or given an overall ranking. It was eventually determined that they were to be ranked by department.
- Ainslie reviewed the prioritization of the NECC CIP list as given to us by the MOA. The additional projects NECC had on our March list that was not on MOA's list had not yet been incorporated into this prioritization. Ainslie and Steve Sommerfeld, who volunteered to be on the committee, are to complete the incorporation of these additional projects and forward them to Peggy for submission.
- With that understanding, the following motion was made:

.... The NECC accepts Ainslie's revisions to the NECC CIP list, to be submitted to the MOA CIB.

Motion passed: 16 in favor; 0 opposed, 0 abstaining.

# (4) NECC Bank Account Audit, Mary Pedlow

- Audit covered the period from June 30 2002 to June 15, 2006. The audit was conducted by the committee appointed at the May executive board meeting: Mary Pedlow, Bobby Scott, Charlie Fahl, and Bob Reupke.
- Found one stale check from February 17, 2005 for \$5 that had not been deposited. No other irregularities were found.
- Recommendations: Leger needs to be updated more regularly; bank statements need to be kept on file, even if there is no account activity; need to verify the EIN number used by the NECC; cashiers checks / money orders need to be filled out in whole (include a memo line).
- Peggy requested that a written audit report be given to the Board for our records.

### (5) Announcement: NECC Election Procedures, Peggy Robinson

- Bob Roses and Peggy Robinson (former and current NECC presidents) met and devised a series of procedures that will be available for future NECC elections.
- The procedures were presented for discussion, not for NECC action or approval. They are a draft guideline that will be available to future election committees, who will have some latitude in the implementation.

#### (6) Announcement: Title 21 Workshop, Peggy Robinson

 There will not be a regular meeting of the NECC in July. Instead, a NECC workshop on MOA Title 21 will be held at the regular meeting time.

#### **NEIGHBORHOOD CONCERNS:**

- Sheila Howe: Announced the "Kaboom" parking building project at Russian Jack Park on June 21<sup>st</sup>.
- Ainslie Phillips: Announced that Dean Architects was before the MOA assembly approval for the rezoning of Peck and Warner circle. (Dean if we put this in there, then we also need to put that subsequent to the meeting, their application was reviewed and they had made no such claim. I'd rather just drop the accusation.)

After some discussion, the following motion was made (the motion was allowed as a time sensitive matter):

NECC June 15, 2006 Motion (1):

The NECC asks that the Municipality of Anchorage reject the rezoning application until such time as the developer has presented site plans to the NECC membership and the appropriate Municipal commissions addressing drainage, access, topography, and impacts on surrounding properties and public facilities.

This motion passed: 16 in favor, 0 opposed, 1 abstaining.
