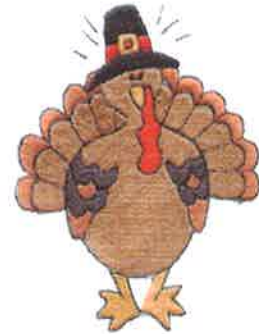

CIRI is working closely with CITC. They offer scholarships for Alaska Natives to go to school, project grants and heritage preservation. They have an Alaska Native Artist in the Schools Program. They give 1.2 million a year to community programs such as these.

**Jay Brause-Out North Contemporary Art House** Jay came to thank the community for its support of Out North. The Municipality of Anchorage officially transferred the building to Out North on July 1, 2004. They are looking forward to filling their new space with rehearsal and performance space, as well as an expanded gallery and possibly someday a café. Jay and Gene have purchased the house next door (to the south) and are busy converting it into artist housing. They are seeking out other affordable (fixer-upper) housing potentially in the Airport Heights neighborhood.

**Other Concerns**

- "Community Park" lot on NW corner of Bragaw and Northern Lights. What will become of it? Great place to connect Chester Creek trail sections. Concerns to protect this green space in our neighborhood. Neighbors take action before it is developed into something the community does not want.
