

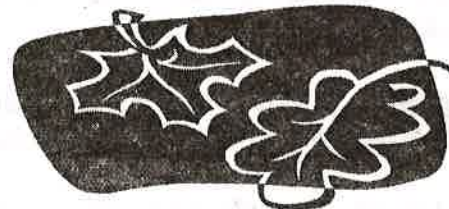

Airport Heights Community Council May 15, 2002 – Meeting Minutes Summary

Members present: Dick Snyder, Jan Schurman, Fred Schurman, Whitey Geddes, Sister Noreen, Calvin Winey, Bernita Hamilton, Alycia Wendt, Barbara Karl, Gretchen Pikul, and Bill Boyd.

Guests: Doug Van Etten (Assembly), Tim Potter (DOWL Engineers), Dee and Richard from Senator Bettye Davis office via telephone, Ryan from Representative Les Gara office via telephone, and Dave Diller (CRW Engineering).

Meeting was called to order at 7:02 p.m. by Chair Bill Boyd. Introductions were made.

Assembly Report: Assemblyman Doug Van Etten discussed panhandlers issue, June 6 work session, and passed out the Assembly Report summary sheet dated May 13.

Legislative Report: Ryan from Representative Les Gara office discussed lobbyist registration and hours, RCA contract, and educational cuts. Richard from Senator Bettye Davis office discussed the bill to eliminate longevity bonus, coastal area issues, lawsuit against Prudential Vista bill, and labor and commerce codes task force. Call the Senator at (800) 770-3822 with any issues.

Zoning Report: Tim Potter from Dowl Engineers discussed the Universal Health Services request to change the current zoning, and add an 18-bed juvenile/adolescent facility behind the existing hospital. This facility would not have lock-down capacity, and would be follow-on treatment to the main facility acute care, if necessary. The building would be 1-2 stories and would abide by the current height restrictions. The public hearing is schedule for June 9. Sometime in the fall a design will be presented to the council.

Traffic Report: No report.

Parks report: Dick Synder reported that the Tikishla Park playground equipment will be installed this summer, and the Davenport play area upgrades will be completed. Dave Diller of CRW Engineering Group, hired by MOA, discussed the Anchorage Areawide Trails Rehabilitation Project and passed out informational pamphlets and questionnaires.

Community Patrol: Nothing noteworthy.

Federation of Community Councils Report: No report.

PTA Report: The PTA is trying to raise \$20,000 for installation of the new playground equipment, and within the first week raised \$3,000. Other fund raising activities will include a dance, pancake feed, and garage sale.

Old Business: The Community Council is still looking for new board members. A nominating committee will be gathered in September for an October vote.

New Business: Complaints were voiced on basketball hoops on neighborhood sidewalks, and children playing in the streets. Doug Van Etten offered to talk with the police regarding these issues.

Motion made and seconded to adjourn. Meeting adjourned at 8:15 p.m.
