CALL TO ORDER - COMMITTEE OF THE WHOLE

Due to a lack of a quorum, the President called a Committee of the Whole to order at 7:08 PM.

APPROVAL OF MINUTES

A motion was made and seconded to accept the minutes from the May 19, 2005 meeting. Motion was approved unanimously by the Committee of the Whole.

Secretary Note: The Council's June and July meetings were cancelled at the May meeting.

CALL TO ORDER

Due to the existence of a quorum, a motion was made and seconded to call the meeting to order. Motion was approved unanimously.

The President called the meeting to order at 7:35 PM.

A motion was made and seconded to endorse the Committee of the Whole's approval of the minutes. Motion was approved unanimously.

REPORTS

<u>CBERRRSA Road Board</u> – Ted Kinney (688-2477), Chris Hudson/Alt (696-1037) – Ted reported via email:

Chip Seal Work:

- The straight runs have been completed.
- This work would have been accomplished faster, had the weather cooperated.
- Steep hills and stopping zones received an application of more coarse chips to provide better winter traction.
- Radius work at the intersections is in progress.
- Paint striping of applicable roads, e.g. Oberg and Old Glenn Highway (Eklutna), is in progress; Oberg Rd's striping was moved to accommodate pedestrian traffic.
- The additional emulsion that was applied to many roads is intended to strengthen the "mat" and better hold the chips in place.

Gravel Upgrade Program:

- Work will begin shortly, now that the major chip seal work has been accomplished.
- Our primary roads are Darn Ave. and Fire Lake Drive.
- Fire Lake Drive right of way issues have not yet been resolved. MOA/ROW staff is still
 attempting to obtain approval from the property owner. If that fails, we intend to upgrade
 the portions that do not have right of way issues.

Residents had mixed reactions about the chip seal results. Some residents stated that the sharp shards in the chip seal have ruined the roads for rollerblading and even dog-walking. The quality of the work was questioned. On the other hand, the work on Thunderbird Heights was reported to be excellent.

Eagle River-Chugiak Parks & Recreation Board - Ray Burger (688-3835) reported:

- The Beach Lake Park Chalet's parking lot expansion required more excavation than originally planned.
- Beach Lake Park's ski trails were compacted and lighting was added.
- Peters Creek Park's new disc golf course was unveiled at the Bear Paw Festival by the Alaska Disc Golf Association.
- Parks & Rec is now managing the horse park at Loretta French Park via a caretaker.
- The Chugiak Volunteer Fire and Rescue Department and Parks & Rec are trying to purchase the old GEM auto repair buildings on the Old Glenn using a \$375,000 state grant plus matching funds. The buildings would be shared between the two departments, primarily to store and maintain equipment.
- There is temporary public access to Mount Baldy via Eklutna, Inc.'s free land use permits and a rental agreement between the MOA and the Caywoods. A permanent solution is being worked which might involve a land trade.
- Members are asked to suggest possible capital projects for Parks & Rec. One suggestion was to reopen the Peters Creek Park campground.

There was a suggestion that a letter or news item should be written to recognize and thank the Boy Scouts and Girl Scouts for their outstanding volunteer work in Chugiak-Eagle River's parks as well as for the many other public services they perform.

<u>Federation of Community Councils (FCC)</u> – Merten Bangemann-Johnson (688-6575), Dave Baldwin/Alternate (688-6158) – Merten reported:

- The FCC will host an open house at its new and improved location on September 20th at 6pm.
- FCC's funding for 2006 is very likely to be approved by the Assembly at approximately the same dollar level as this year.

Chugiak Community Council Treasury - L. Kovac (688-5356) reported:

 There was \$1,651.58 in the savings account which included a \$17.00 donation from members attending the May 19th meeting.

On-Site Wastewater System Technical Review Board - L. Kovac (688-5356) reported:

 The proposed well code will go to the MOA legal department and then to the Assembly for a public hearing and Assembly approval.

Old Glenn Project Citizen Committee (ADOT&PF # 52515, www.oldglennhighway.com) - L. Kovac (688-5356) reported:

Utility Relocation Resulting from the Old Glenn Project

In April, a letter was sent from the Council to all of the utility companies involved with relocations along the Old Glenn requesting: they relocate their utilities to create as narrow a footprint within the ROW as possible; information about any related issues. To-date, no replies have been received from the utilities. One resident suggested that under-grounding electrical and phone lines might save some land.

In July, Mr. Ken Morton, Engineering Manager, ADOT Traffic, Safety & Utilities (269-0686), was contacted to determine if utilities could be placed under the pathway on the Old Glenn to keep the construction as tight as possible. Mr. Morton responded that, even though his department is planning a parcel by parcel evaluation regarding utility relocation:

- ➢ Given the Old Glenn's wide ROW, utilities will not likely be located under the pathway but rather in the untraveled portion of the ROW to reduce costs of future relocations.
- > The AWWU work will likely take the most room (beyond the "blue" cut and fill lines indicated on DOT's preliminary drawings).

ROW Encroachment HB 279

House Bill 279, that would permit right-of-way encroachments along the Old Glenn in some cases, was signed by Governor Murkowski on June 24, 2005 and becomes effective on September 22, 2005. Funding to begin the task of bringing the encroachment application on-line will be available sometime after the September date. Until then interested parties can download the application at:

Warning about Recent Fraudulent Emails

In mid-July, Members reported receiving fraudulent emails:

- One such email began "Welcome to the Oldglenn@chugiakcouncil.org mailing list!" Unsuspecting recipients were invited to reply to this email in order to join a bogus mailing list while supplying personal information and passwords.
- In another email, the sender appeared to be the State of Alaska, the subject line stated "Re: Order", and the body of the email merely stated "Thanks". Unsuspecting recipients might be tempted to respond back to such an email to ask what the email was about and to explain that they had not ordered anything.

These emails, that pretend to be legitimate services, are scams devised by creeps who want to find out your personal information. **DON'T BITE – DON'T RESPOND TO THEM**.

The President stated that the Chugiak Community Council does not give out your email accounts and does not use online list servers. The Council uses your email account only to provide you with information on Council issues. The Council provides links to agendas and other documents in our emailed notices to you so that you will not have to open attachments.

<u>Title 21 Update Committee (Land Use & Zoning Code Rewrite)</u> – L. <u>Large Animal Ordinance Committee - Dave Baldwin (688-6158)</u> There was no report as Dave was unavailable.

PRESENTATIONS

Chugiak Benefit Association (CBA) Proposed Gravel Operation

Bill Waddell/CBA President (688-2610), Jerry DesJarlais, and Jack Hayden (both of Denali Materials) presented plans to replace the CBA land and facilities that are being threatened by the Old Glenn Highway's ROW. CBA plans to utilize more of their acreage by excavating their back hill and selling the resulting gravel. CBA estimates there is ½ million tons of gravel available, permitting could take a year, and gravel extraction could take two years. CBA stated that they would comply with all regulations, operate safely, utilize experienced contractors, and minimize impacts to the surrounding community and to the organizations that use CBA.

Denali Materials, currently employed to extract gravel from adjacent Loretta French Park, would be CBA's contractors for this operation. CBA expects that the same conditional use permit conditions for Loretta French Park's gravel operation would also apply to CBA's. These conditions include: gravel operation from 7am-6pm Mon-Fri and 9am-6pm on Sat; no operation on Sunday or holidays; maintenance allowed after hours; maintenance of a log describing complaints and resolutions; and utilization of a water truck to keep dust down on roadways.

CBA stated that once the gravel is removed, there would be six to seven acres of usable space available at the existing CBA building-level. This area would supply space for parking and a playground. There would also be enough room to expand existing facilities and services and accommodate CBA's frequent requests from the community for open space. In addition, one or two water wells would be drilled, the septic system would be expanded or vaulted toilets added, and some trees might remain as a buffer.

Chugiak Children's Services, Inc., FOCUS, Inc., the Dog Obedience Training Club of Chugiak, and the Chugiak-Eagle River Chamber of Commerce are supporting CBA's plans. A motion was made and seconded to endorse CBA's plans and request that the same conditional use permit conditions that are in place for Loretta French Park's gravel operation also apply to CBA's gravel operation. Motion was approved unanimously. The Secretary was requested to finalize and send a letter of support to CBA.

NEW BUSINESS

Planning & Zoning Case No. S-11257-2

The Chugiak Community Council Plat Review Committee held a special meeting on June 25, 2005 to discuss Short Plat S-11257-2. This special meeting was necessary due to the MOA Planning Department's deadline for comments which were due July 15th. The case was scheduled to go before the Platting Officer on July 25th. Members of the Plat Review Committee included Gale Armstrong, Ted Kinney, and Linda Kovac.

This plat was the second proposal to subdivide one tract of land into seven lots in the Voyles Subdivision/West Peters Creek. Last year, Short Plat S-11257-1 was returned for redesign to address the extension of Homestead Road. The new design S-11257-2 has not changed substantively from S-11257-1. The Plat Review Committee requested that the Platting Officer return S-11257-2 for redesign as it fails to adequately address the extension of the Homestead collector for these primary reasons:

- The extension of Homestead Road should be built on dedicated public right-of-way, not easements across private property.
- The proposed subdivision is bounded by a north-south running section line (old "Ramsey Road") and an east-west running section line (Homestead Road). These section lines were originally public easement and now the developer is getting the advantage of utilizing this land for private use. Since the developer has the benefit of these easements, it is appropriate that the developer provide a decent collector road alignment.
- The entry road into the subdivision should be renamed from "Scenic Meadows Circle" to "Homestead Road" to avoid confusion.
- The entry road into the Scenic Meadows Subdivision should be relocated closer to the Old Glenn Hwy (as in the previous S-11257-1 design) in order to make the intersection at Voyles Blvd. more of a right angle and to assist in the logical development of lots.
- The developer should build this collector to similar standards that the MOA required of Arctic Devco to build the Oberg Road collector running through the Tablelands Subdivision. In addition, the developer should leave room on the south side of the collector for the development of a future paved multi-use trail.
- The number of driveways should be further minimized on the collector.
- It was noted that the drainage arrows on Lots 5 and 7 appeared to be pointing uphill.

Ultimately, the Platting Officer approved S-11257-2 subject to several conditions including:

- Changing the street name "Scenic Meadows Circle" to "Homestead Road".
- Resolving the need to dedicate a 70 foot right-of-way for Homestead Road from the intersection of Four Wheel Drive to Voyles Blvd. with a temporary turnaround.
- Resolving the need to construct a paved multi-use trail along Homestead Road.

A motion was made and seconded to endorse the actions taken by the Plat Review Committee in this matter. Motion was approved unanimously.

OLD BUSINESS

Anchorage Long-Range Transportation Plan Update

In August, AMATS staff forwarded a copy of the public review draft of the Anchorage Long-Range Transportation Plan (LRTP) and executive summary to the Council. This plan guides long-term transportation improvements within the Anchorage Bowl and along the Glenn Highway. Additional copies can be picked up at the Municipality of Anchorage Traffic Department at 4700 Bragaw Street or it can be downloaded from the municipal website at www.muni.org/transplan/.

Chugiak-Eagle River Comprehensive Plan Update

The Chugiak-Eagle River Comprehensive Plan provides guidelines for determining the type and location of industrial, commercial, recreational, and residential development and residential development density. It identifies community issues, goals, and objectives to provide a framework for community decision making. It represents how residents see their community.

The Chugiak-Eagle River Comprehensive Plan Update is tied to the current Title 21 Rewrite Project (land use regulations) so that any relevant changes to our Comprehensive Plan will be implemented in the update of Title 21.

A Citizen Advisory Committee (CAC) is currently meeting weekly to update our Comprehensive Plan. The CAC includes representatives from the community councils, the road department (CBERRSA), the parks department (ERCPRSA), the Chugiak-Eagle River Chamber of Commerce, Eklutna Inc., and MOA Planning. The first draft section of our Comprehensive Plan called "Guidelines for Growth" was distributed to Members who were asked to provide comments. These draft guidelines will be followed by another section of the plan called the "Land Use Plan" which designates land use and sets residential density.

These initial comments were voiced:

- Site condos should not be allowed in Chugiak.
- B-3 zoning with special limitations is too restrictive.
- There should be more retail space for small business owners.
- There should not be pockets of industrially-zoned areas. They should be consolidated.
- The Birchwood Airport is the logical place for more industrially-zoned land.
- Outdoor ventures should be encouraged.

Annual Municipal Capital Project Survey

The Secretary presented the following list of prioritized capital projects compiled from Members' suggestions. The list was submitted to the MOA Budget Department on June 15^{th.} The first part ranks capital projects.
