ENGINE BLOCK HEATERS AVAILABLE

Thus far this winter, almost 2,000 engine block heaters have been installed in Anchorage vehicles as part of a campaign to reduce carbon monoxide air pollution emissions in the Anchorage bowl. Qualified residents in the Anchorage bowl can have an engine block heater installed in their car or truck for just \$25. Appointments for installations can be made by calling Agen's Automotive at 563-2436. Jerry's Auto Service also has a limited number of appointments available at 344-2735. Appointments will continue to be taken until accessible slots are filled up, with a March 1st deadline. Most vehicles are eligible for the program, but some restrictions do apply. Agen's and Jerry's will be able to assist in determining eligibility.

Those who already have a block heater in their vehicle can pick up a free programmable timer at the Municipal Department of Health and Human Services. A timer can be used to turn on your block heater for two or three hours prior to starting and cut carbon monoxide emissions by almost two-thirds. Using a timer allows you to save electricity while getting the full benefit of plugging in.

These programs are funded through AMATS (Anchorage Metropolitan Area Transportation Solutions) using Federal Highway Administration money that is earmarked for air quality improvement projects. These monies are made available to areas that do not meet federal air quality standards. The EPA currently considers the Anchorage bowl area as a no attainment area for carbon monoxide, and residents in this area are eligible for the program if they have a valid vehicle registration, are in compliance with I/M program requirements and regularly park their car outside overnight. The Anchorage bow is defined as the area between the Glenn Highway's Muldoon on-ramp on the North, and Potter Marsh on the south. Eagle River and Girdwood residents are not eligible for the program. With the large number of apartment complexes in Fairview, this program could help significantly reduce carbon monoxide in our community. PLEASE TAKE ADVANTAGE OF THIS PROGRAM!
