UNDERGROUNDING OVERHEAD UTILITIES

Mr. Phil Steyer, Manager of Government & External Affairs w/ Chugach Electric Association, spoke at our last meeting on February 23rd about the ordinance to place overhead utilities underground. Mr. Steyer said the price to underground electric lines is approximately \$1 million per mile. He also said that the other utilities that share the poles will have the opportunity to underground their lines at the same time. If they decide not to place their lines underground at that time, Chugach will cut off the top of the poles and turn ownership of the poles over to those utility companies.
