Approval of 2/26/03 minutes Sam moved the approval of minutes, accepted.

Treasurer's Report Mary Jo reports that we have 478.67 in saving 126.25 in checking

New Business: Chief Walter Monigan visiting, Bonnie Jack reports that she has e-malls going back 1991, 1054 W 20th, Dog problem earlier, and later a people problem. Videø, photos, June 99, 2000, 2001 license plates. Have officers names, dates, and excuses given. Fee for calling police, confiscation of car w/o insurance, neither ordinances are being enforced. Anne has a 3, 9, and 14 year old. 14 year-old is developmentally disabled. Traffic incidence on Arctic. Jennifer is beyond outrage people disturbing at all hours of the night. Health and Safety Is being compromised. There are drugs at this particular place. Cocaine. One man was shot. Granddaughter taking in trash. What steps do we take?

Larry: Watching the "worst one" w/brown camero, Jesse Ackman. Was star witness in murder trial Joshua Wade trial. Got in trunk took something out, got back in car with passenger. Prostitution from Show Boat.

Jean: Ruby, Jesse's mother. It's a dead end street and it is a caring area. Threats have occurred so neighbors are starting to back off. There are fights, these people have been trying to run others over. Probably a Meth lab before the fire. Landlord is unwilling.

Bonnie: Dispatch now recognizes address. On Sat. March 15th officer Blatten came out talked to the infamous white cadillac, but then left. He chose not to write a ticket because he doesn't know the history. This man is a friend of Patrick Bailey aka. Orlando Sanchez. Why isn't the law being implemented?

Loreena: Lived short time and found neighbor's tenants intrusive, often they were in the yard (the dog too), they were loud, flip cigarette butts into her yard. It was infringing on her life and income (tenants). Called several times about noise complaints. One night woken up by police responding to some sort of assault at the back apartment (Jesse Atkin's apt.).



Why when police come don't they write tickets,

Chief: You shouldn't have to move. Citations are always discresionary. He is a warning person. Only when a vehicle is on a public street then they are impoundable. The car can be impounded if the person is there. Parked cars can be ticketed, not impounded.

Meth Labs are a Haz Mat problem. Letter to the registered letter to the owner listing all the activities happening. Policy must be circulated through the Department about police calls. Mark Mews is the head of that dept. He has had his hands full with 911 EMS issues. Policy has to run through legal, it must stand legal scrutiny. RMS (records management system) can still record the necessary information. Traffic control on Arctic, will assign officer to work on specific structure. The achillies heel on civil abatements are that they are long arduous and sometimes circumnavigatable. When property owners change the civil abatements start from the beginning. If the star witness is arrested then the defense will jump on that action. Lighting is not an issue. Threats are not against the law unless there is an act of furtherance. Assign officer to make a master case number, let everyone know who this officer is, cross-reference cases, and updates to community council until the problem has been abated. Call about sound issues after 10pm.

Anchorage Tomorrow -Bonds Purpose is to educate about the bonds so people might consider voting for the bonds. Anchorage people should vote yes on Eagle River Bonds so that ER people can vote to pay for their Bonds. Anchorage will not have to pay for ER bonds. Sam endorses Skate Board Parks.
