Proposed Amendment to Russian Jack Community Council Bylaws

The following articles of the Russian Jack Park Community Council are proposed for amendment. These amendments will extend voting rights to council members sixteen years of age or older, require members to attend a minimum of three meetings a year in order to vote on the election of officers or by-law amendments, assure Municipal Code is adhered to with regard to finances, and allow for the use of electronic mail in distributing notice of proposed changes to the by-laws.

These changes are intended to encourage and reward the participation of active council members between sixteen and eighteen, prevent special interests from exercising undue influence over the council, ensure our bylaws remain in line with Municipal Code, and bring the distribution of information up to date by allowing for the use of current technology.

Amendment 1

ARTICLE IV - MEMBERSHIP

Any person [OF LEGAL VOTING] at least sixteen years of age or older is eligible for membership, provided the person is a resident, homeowner, tenant, property owner, business owner, board member or local manager of a corporation, or of a non-profit association within the defined area, and has signed the membership list.

Amendment 2 ARTICLE VI – VOTING

Section A.

Each eligible member who has signed the membership list shall be permitted to vote on issues before the Community Council. However, in order to vote on revisions to bylaws or election of officers a member must have attended at least three meetings prior to the meeting at which the vote is to take place in the preceding twelve months.

Section [A] B.

Each member of the RJPCC shall have one vote, even if an individual possess several properties or businesses within the area.

Section [B] C.

Each member must be present [A THE TIME OF THE VOTE] to vote. Proxy voting is not allowed.

Amendment 3

ARTICLE VIII - OFFICERS

Section A. Positions

The RJPCC Officers are the President, Vice President, Secretary, Treasurer, and Trustee. In order to serve as an elected officer, a person must be a member of the Council.

Amendment 4

ARTICLE IX - FINANCES

Section B.

The RJPCC may not receive [VOLUNTARY] contributions in excess of \$250.00 per year from [EACH] any member [OR UNLIMITED IF NOT A MEMBER], business, or other organization to meet the costs of its operation as per AMC 2.40.030 [(MUNICIPAL CODE)]. The RJPCC shall follow Municipal Code with regard to contributions.

Amendment 5

ARTICLE XIV - AMENDMENTS

These by-laws may be altered, amended, or repealed by a two-thirds (2/3) vote of the eligible members present at a general or special membership meeting if at least fourteen (14) days written [AND MAILED] notice to all members on the Sign In Sheets within the previous six (6) months is given of the intention to alter, amend, or repeal the by-laws at such a meeting. Such notice may be made in the form of electronic mail. The notice shall include a statement of the articles to be changed and the reason.
