## **Assembly/Legislative Updates**

MOA Assembly update (Chrystal Kennedy)

Kennedy gave an update on the Metropolitan Transportation Plan (MTP). Many of the concerns of residents about intersections have been addressed, such as the Highland Road intersection, the Glen Highway, and Artillery Road. Department of Transportation is delaying the process concerning Artillery Road until the community has had a discussion to discover what it wants now instead of what it wanted 20 years ago. The Anchorage Assembly is forming their comments to put into the MTP report. For more information, read the MTP report at www.MTP2040.com.

The Municipality will be releasing a list of local trails that are designated as non-trapping areas.

ERHS students have created a resolution to the mayor to change the name of Yosemite Dr to Wolf Den Dr.

There was a meeting concerning the Eklutna River Restoration Plan. No progress has been made since removing the dam because there is not enough water flow to restore the fish population.

Kennedy was approached by a cannabis company called "Good Cannabis" from Fairbanks. The company has expressed interest in opening a marijuana shop in Eagle River. Kennedy gathered feedback from the community.

The Chamber of Commerce will host Congressman Don Young for lunch at Matanuska Brewing Company on February 19, 2020.

Kennedy updated the Community Council concerning an ordinance that passed the Assembly that allows the MOA to create a bond for specific roads. Though she initially sponsored it, she fears this will diminish the ability of the Eagle River Road Board to tax and control projects in the Eagle River/Chugiak area. She is attempting to amend the ordinance to include that the bond option can only be used if no other methods gathering funding exists.

• Anchorage School Board update (Elisa Vakalis)

**Budget** Update

The ASD School Board will have the first reading of the budget on February 18, 2020. The budget is projected to be \$875 million, \$10 million less than last fiscal year. They started with a \$20 million deficit and cut \$14 million outside of the classroom, but cuts had to be made within the classroom. Most of the inclassroom cuts were to the elementary students by restructuring the delivery of health classes and the Ignite program. There will be minor changes for middle school students and the high school students are losing one AP class and three security officers. Vakalis encouraged the community to voice their concerns.

### **Bond** Update

There will be a new bond on the upcoming ballot for \$82.8 million, which will be a two-year bond. If this bond passes, ASD will not bond next year. Of the \$82.8 million, \$60 million will be used for the campuses in Chugiak/Eagle River.

Two seats are currently open for the ASD School Board.

- Nicholas Bell, ASD Project Manager for Eagle River Elementary: The Administration directed Bell to expand the scope of the project to not simply repair the facility, resulting in a higher estimate than the \$12 million than was initially expected. At the end of February, his project will begin the procurement process and in March it will be open to receiving bids. After the ASD School Board has approved the bid, it will release the contract by May 2020. It will be the lowest bid procurement process due to FEMA requirements. The project will be worked on throughout summer with the goal of opening in August 2021.
- Eagle River Community Patrol update (Cliff Cook/John Rathert)

Cliff Cook reported 170 miles driven and 20 driving hours. Mail theft has seen an uptick in Chugiak/Peters Creek, specifically for older style mailboxes. Cook encouraged residents to report suspicious activity to 311 and reserve 911 for emergencies.
