Later Day Saints Church

I recently emailed my contact for the LSD church being built at the corner of Muldoon and 36th Ave, in reference to the sewer line that was supposed to have been connected at Pioneer and 36th. After doing a more elaborate site survey, they discovered that several years ago one of the previous owners of the property had installed a branch off the main trunk sewer line which terminated

on the project property. They had been unaware of it because it hadn't been recorded. Currently the contractor has been given the permit and go ahead to perform the site work and prepare the site for foundation and footings. They are expecting the building permit shortly.
