

Greetings to Members of Our Community Council:

You know of course that we have been pursuing and questioning Chugach Electric Association's attempts to construct an aerial high voltage transmission line in the Alaska Railroad's corridor running through our council area. At our last council meeting we were informed by a member of the Planning and Zoning Commission that the commission just found out that P&Z had no authority to grant to CEA the change for the use of the corridor which is necessary before the transmission line can be constructed, and that the change would have to be approved by the Anchorage Assembly. On April 4, 2003, the Assembly has scheduled a work session to discuss the CEA transmission line. Officers of your council along with business owners, and residents will attend this public meeting but will be unable to participate. We will advise you of what we leaned at our April 17th general meeting.

Another big issue for our council is the under-21 nude entertainment clubs. Anchorage currently has clubs where alcohol is not served, but 18-year old dancers are employed. My understanding is that nudity does occur, and that patrons are usually much older than the dancers.

Anchorage has laws on adult entertainment, etc., but not for 18 year olds - many still in high school - dancing in what may be called non-alcoholic teen strip clubs or otherwise known as adult caparet.

Taku-Campbell Community Council is very concerned about our community allowing nude entertainment venues to young people under 21 years of age. We feel that this presents unnecessary and undesirable risks and choices to our school children and other young people in our community.

We are additionally concerned about the potential negative impacts these establishments can have on the community. We would like to see the community councils notified when license applications are made for "adult-oriented establishments." The following characteristics do not sound like those of a good neighbor: "AMC 21.45.245: Standards - unlicensed nightclubs, AMC 21.45.240; Location of premises where children are not allowed. A. Purpose. Certain types of enterprises are places where children unaccompanied by an adult guardian or parent are prohibited. These enterprises have been determined, by court-accepted independent studies, to produce secondary impacts on surrounding land uses. The impacts include a decline in property values, and increase in the level of criminal activity, including prostitution, rape and assaults, in the vicinity of these types of enterprises, and the degradation of the community standard of morality by inducing a loss of sensitivity to the adverse effect of pornography upon children, upon established family relations, and upon respect for marital relationships. The purpose of this section is to segregate such enterprises from places frequented by minors in order to reduce the influence of these enterprises on minors."

The TCCC Steering Committee supports the following recommendations by the Anchorage Council of PTAs:

- 1. Raise the minimum age limit for attending or working at any nude entertainment clubs to 21 years old. (e.g., AMC 8.50.010, AS Sec. 11.66.300 and Sec. 23.10.350).
- 2. Put these businesses and nude entertainers under stricter licensing requirement, building codes, and health inspections.
- 3. Disallow license for prior convictions related to prostitution, alcohol, and drugs.
- Notify Community Councils when license applications are made for "adult-oriented establishments."
- Ban alcohol in nude entertainment businesses that don't have a license to serve (no BYOB).
- 6. Increase enforcement of current and new regulations.

According to an article in The Anchorage Chronicle, PTAs Push for Community Discussion of Under-21 Strip Clubs - New nude, nonalcoholic entertainment venue opens, by Heather A. Resz, Staff Writer, Anchorage Chronicle, March 20, 2003, "Anchorage's newest under-21 strip club opened March 14 at 64th Avenue and C Street. Wolffie's is a private club that closed temporarily after losing its liquor license. Business owner Dave Wolff said he bought the building from the bank about three years ago. He has reopened it as an under-21 nude dancing club after his club's liquor license was suspended. "

Assembly To Listen To Chugach Electric Association's Proposed High Voltage Line Through South Anchorage

Chugach Electric Association (CEA) is scheduled to make a presentation to the Assembly at a regularly scheduled work session on Friday, April 4th from 3-4 PM.

The Work Session will be held at the Assembly conference room on the Ground Floor of City Hall. Observers are welcomed, but there is no public participation during work sessions.

Taku Campbell Community Council (TCCC) has heard from numerous residents and business owners that they have concerns about this proposed high voltage line. This notice is being provided as part of TCCC's role to provide information about issues important to our area.

In order for the high voltage line to be constructed, an amendment to the Utility Corridor Plan is needed, which the Assembly must approve. CEA will likely focus its presentation on the need to amend the Corridor Plan and the need to expand service capacity in South Anchorage.

As is typical with public meetings, it will likely convey concern and interest to the Assembly if a number of residents and business owners are able to attend this meeting.

Engineers from Lounsbury & Associates will present the results of their traffic analysis and identify recommended improvements for the Arctic Boulevard @ Potter Drive Highway Safety Improvement Project completed on behalf of the Municipality of Anchorage. The project was initiated in this area because of high accident rates -44 between 1998 and 2000. The primary intersection of interest is the four-way intersection of Arctic Boulevard Potter Drive and west 54th. Of secondary interest are two tee intersections of Arctic Boulevard with West 54th Avenue and West 53rd Avenue.

PLANNING & ZONING COMMISSION

Community Council Redistricting - Project Update:
The Planning Department is drafting an ordinance to introduce the Planning & Zoning Commission (P&Z)
Community Council Redistricting - Report and
Recommendations case before the Assembly. It appears
Assembly introduction will occur in the second half of April.
When the case is introduced, the Assembly will establish a public hearing date, which will likely be in May.

As part of the ordinance, Planning is preparing an atlas of community council maps intended to serve as a reference for the public once boundaries have been adopted. As with any other case, because an Assembly decision may differ from a P&Z recommendation, the draft ordinance and its boundary maps are designed to be changeable to align with the boundaries the Assembly does adopt. The draft ordinance merely codifies the P&Z recommendations and maps. It makes no change to content.

There are five improvement categories, based on the primary goal of the project. The categories are roadway improvements, safety improvements, drainage collection improvements, drainage treatment improvements, park improvements, and miscellaneous improvements such as park amenities, trails, and equipment.

The CIP development schedule is updated annually in response to evolving community needs and priorities. The typical schedule for this process is:

- 1. Community Input (February April)
- 2. Project evaluation and prioritization (April May)
- 3. Draft CIP is developed (May -June)
- 4. Internal review by municipal agencies (June August)
- Assembly approval and final public comment (Sept.-Nov.)

DOWLING ROAD EXTENSION - UPDATE

The Alaska Department of Transportation and Public Facilities is continuing to work on the Dowling Road Extension study. The purpose of the study is to provde a new east — west road connection between Dowling Road from the Old Seward Highway west to Minnesota Drive. The DOT&PF met with local businesses, neighbors, and agencies last fall to hear concerns, answer questions and discuss ideas.

People who have participated up to this point agree that the area needs another east-west road connection. Businesses are concerned about how difficult it is to get in and out of their businesses. They are also concerned about mixing heavy truck traffic with local neighborhood traffic. Neighbors are concerned about traffic, noise and improving safety for both cars and pedestrians. Agency input included improving emergency response time in the area, concerns about impacts to Campbell Creek and Tina Lake, and improving traffic flow.

The next steps include developing east-west road connection alternatives. The DOT&PF will hold another series of meetings in the spring of 2003 to discuss the range of alternatives with the local businesses, neighbors, and agencies. A preferred alternative will be identified in the Winter of 2004.

AIRCRAFT FLIGHT PATTERNS TO CHANGE - MORE NOISE OVER TCCC

Mark Butler, Community Relations Manager of the Ted Stevens Anchorage International Airport will be at the April 17th general meeting to give a follow-up presentation on this summer's airport construction season. Reconstruction of the North/South runway, airfield lighting and completion of the new Taxiway Yankee are included on this year's list. As a result, you may observe aircraft flight patterns not normally used, as well as greater frequency of flights over the community during the construction period.

Mr. Butler and TCCC will work together to keep the community informed. We plan to provide project updates as they become available.

ARRC DOUBLE TRACKING PROJECT

Alaska Railroad Corporation reports that construction on the Campbell Creek Bridge is underway and should be completed by May 6th. The entire double tracking project in the South Anchorage area should be completed by June 15th. According to Bill Houghton, AARC's project manager, completion of this project will increase overall efficiency. Gravel movement and passenger movement could take place simultaneously. The Double Tracking Project could increase through traffic but eliminate the need for switching activities between Dimond Blvd and 76th. Ave. However, when asked if the track switching mechanism in this area would be removed, the answer was no. AARC would still use the switch for emergency switching.

AARC has scheduled gravel trains to operate on the new (west) track and passenger trains will continue to operate on the existing (east) track. Businesses and residents adjacent to the tracks will notice increased train activity. However, John Fuglestad, Vice President and General Manager of Quality Asphalt & Paving and Stephanie Wheeler, Public Involvement Officer of ARRC has assured TCCC that under normal operating conditions, train activity will be confined to the hours of 6am and 10pm.

We understand that a Grade Separated Crossing at C-Street would also lessen the congestion and reduce the negative impact on our community. Since C-Street is scheduled for reconstruction anyway, we will pursue this possibility with city planners and DOT.

PARKS PLAN REVISION

Reprinted from the RCCC Newsletter

Public Participation Requested. The city is in the process of revising our Park, Natural Open Space and Recreation Facility Plan. Advisory groups (Community and Technical) have met with the local planning team (Land Design North who partnered with Indiana University's Eppley Institute for Parks & Public lands.) The public involvement process will continue in April and town hall style meetings and work-sessions which will compliment a public survey to be sent this month. The planning team conducted interviews with user groups who identified key issues to address in the revision. Some of the issues are: partner with schools to integrate sports fields usage; ensure Chugach State Park access as residential development occurs; develop a critical land acquisition strategy' ensure park lands are in "dedicated" land status; balance facility types (organized vs. non-organized facilities); maintain & improve the existing parks/facilities; consider potential for winter tourism & economic value; Interface number of neighborhood parks' connect existing parks/greenbelts with trails; adequately fund parks; obtain specialized staff such as an urban forester.

TCCC PARK SURVEY

TCCC HAS been identified as a key group that will eventually benefit from a well-planned park system. Land Design North (LDN) and the Anchorage Parks and Recreation Commission have invited our council to participate in filling out a questionnaire and to provide important information on future parks, greenbelts and recreation needs of our council area. Representatives of the LDN project team will be holding public meetings during the week of April 7 through 11 (a schedule is available on the municipality web page). Council members, park users, and people that live and work in the area are encouraged to participate in identifying our community's parks, natural open space and recreational facility needs for the next 20 years. ANCHORAGE RECEIVES GRANT TO HELP SPECIAL NEEDS RESIDENTS IN EMERGENCIES

The City of Anchorage recently received a three-year, \$900,000 grant to identify and help residents who may need extra help or attention during natural disasters or emergencies.

The Federal Homeland Security grant was given to the Municipality of Anchorage's Department of Health and Human Services. The department will focus on ways to mobilize volunteers to visit homebound / frail and residents with special needs in their homes. Volunteers will provide residents with emergency preparedness instruction, assess homes for hazards and provide them with emergency preparedness supply kits. In addition, the department will work closely with agencies serving special needs populations to retrieve voluntary personal information. The information will then be used to develop and maintain a centralized database for public safety and emergency response teams. Currently, there is no method to account for the homebound/frail or vulnerable populations that exist in Anchorage.

The department has already teamed up with the Anchorage Watchful, Alert, and Ready for Emergencies program (AWARE) to train volunteers.
