- Robin Baizel, of DOGMOMS, presented dog safety and dog rules to the council. Children and dogs were discussed, hearing that the higher pitched children's voices and energy can excite a dog. Planning Department requested that these streets be included, as referenced in the May 2003 final draft of the Study. There was lengthy discussion on the amount of traffic going through this residential area, especially on East 42nd Avenue, and the concern that something needs to be done for safety reasons sooner than later. There was disagreement to East 42nd Avenue becoming a collector street. It was felt that the city brought the increased traffic to this neighborhood when 42nd became a cut-through for avoiding the Tudor/Lake Otis intersection. The traffic changed dramatically in 1975 when Tudor Rd was widened, vehicles rerouted to East 42nd, continuing with APD detouring traffic there following Tudor Rd incidents. It has increased further since the South access to Providence from Tudor was opened. The neighborhood should not be required to pay for needed safety and road improvements.

• LAST CALL to property owners along Chester Creek: Craig Valentine informed the council of Federal grant money that is available for Chester Creek rehabilitation, from the US Department of Agriculture. Chester Creek is one of the few streams in the United States that individual people own from their property to the middle of the stream. Property owners along the Creek can contact UACC's president, 333-4952, for an application.

approved. This is a "framework" plan to provide guidance in development of the district east of Lake Otis, south of Northern Lights and north of Tudor Road. The various institutions are still working on their individual plans to fill in details of this framework. For neighbors concerned about traffic in and around E. 42nd Ave., the plan was amended through Doug Van Etten's efforts, to require that a traffic circulation study be completed before any roadwork - planning or construction - can take place. Included in that plan will be traffic calming measures and pedestrian safety.

- Dog Park: Draft Additional Rules and Regulations for University Lake Park - September 25. The following were proposed by the Animal Control Advisory Board to the Parks and Recreation Commission. Further approval is needed from the Parks Director and the Director of Health and Human Services prior to implementation.
  - 1) Specific trails within this park may be closed to off-leash use on a seasonal basis. Such trails will be clearly posted.
  - 2) Notice of permitted events shall be prominently displayed throughout the area one week prior to the event.
  - 3) Clear posting of designated off-leash areas at all entrance/exit points and non-municipal property advised.
- Planning Department launches E-Alert: while paper notices will still be mailed to residents and businesses within 500' of a planning or zoning, platting or other municipal action that has a public testimony process, additional notification is available by e-mail. Sign up on-line to receive e-notices in your immediate area by community council district, or sign up to receive notices from any or all parts of town.
