Homelessness, Housing and Neighborhood Development Commission (HHAND) has three vacancies:

Commissioners are tasked with advising the Mayor, Assembly, Municipal staff, and the planning and zoning commission on issues related to housing, homelessness, and neighborhood development. Over the past 2 years, the Commission has focused on the city's response to homelessness, and will be advising how federal, tax, and grant funds get spent and distributed.

HHAND is the only commissioned body that brings together people from diverse backgrounds to discuss and review these issues, and as such has a unique voice that leadership in the city pays attention to.
