A RESOLUTION IN SUPPORT OF ACTING MAYOR AUSTIN QUINN-DAVIDSON'S ADVOCACY AND ACTIONS TO PROTECT PUBLIC HEALTH AND SUPPORT HOUSEHOLD RESILIENCE DURING A PANDEMIC

WHEREAS, the State of Alaska Constitution, drafted, passed and ratified with historic knowledge of pandemics, provides that one of the responsibilities of State Government is to provide for the public health,

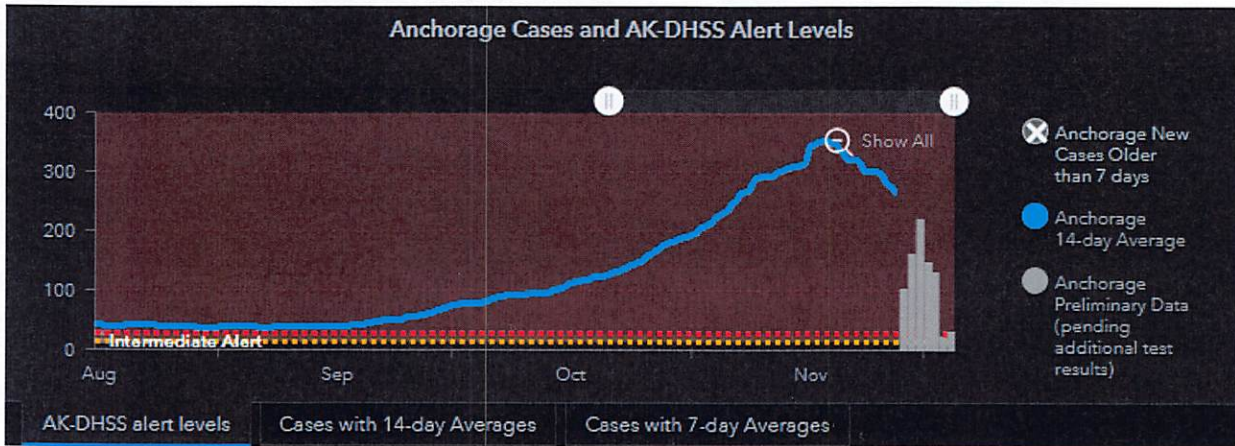
WHEREAS, State Statutes provide that home rule municipalities have the authority to regulate matters of public health,

WHEREAS, the Municipality of Anchorage, under its home rule authority, has the authority and responsibility to act on behalf of the people in its community to provide regulation and advice to protect the public health, a profound and solemn responsibility during a pandemic,

WHEREAS, recent conditions reported by the Municipality of Anchorage (acknowledging that data entry on SARS-CoV-2 positive tests has fallen behind in recent weeks so these counts may underestimate the count and underestimate trends) continue to indicate COVID-19 incidence remains on the order of at least **9 times** above the "RED LINE" for high alert public health risk on the Municipality dashboard for the COVID-19 pandemic [web image December 5, 2020, 2pm],

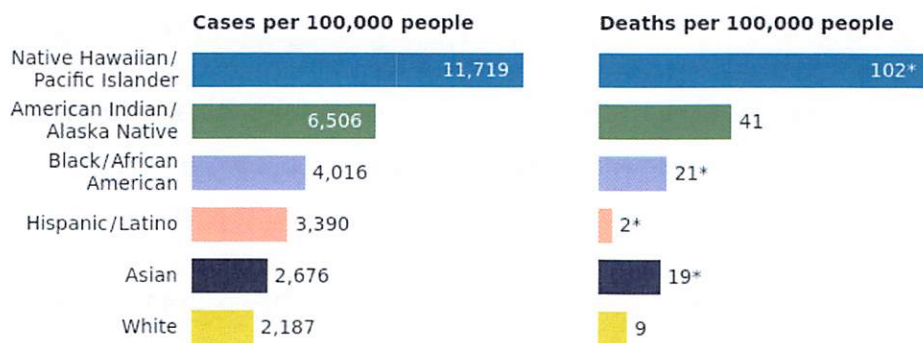

WHEREAS, the COVID-19 test positivity rate for Anchorage reported by the State of Alaska at 7.2% (data download, December 5, 2020, 2pm) continues to run above the public health risk threshold of 5% that has been cited by the WHO as a baseline indicator of adequate testing,

WHEREAS, COVID-19 is a serious disease that has a disproportionately impact on and continues to place at risk the many groups across our state and in our community who have historically been underserved by and provided limited access to health care resources [covidtracking/race/infection and mortality, web image, December 5, 2020, 2pm],

In **Alaska**, through December 4, Native Hawaiians/Pacific Islanders were most likely to have contracted COVID-19 and were also most likely to have died.



Notes: Alaska has reported race data for 78% of cases and 93% of deaths, and ethnicity data for 55% of cases and 79% of deaths. Graphic only includes demographic groups reported by the state. Race categories are mutually exclusive and include both Hispanic/Latino and non-Hispanic/Latino ethnicity.

COVID-19 Lives Versus Livelihoods



WHEREAS, historic evidence in the U.S. suggests that communities that focused on saving people first not only limited the economic cost of the pandemic, but positioned themselves for a strong economic recovery in the year after the pandemic:

At a minimum, our estimates reject that cities with stricter nonpharmaceutical interventions (NPIs) experienced a large decline in employment and output in the years following the pandemic, relative to cities with lenient NPIs. If anything, high NPI cities experience a relative increase in economic activity from 1919 onwards.
