I. Called to Order at 7:03 p.m. via Zoom.

Approval of Agenda: A motion was made and second to approve the agenda as amended - added review and approval of the revised January 28, 2021 minutes; added Tom Davis, Municipal Planning Department, to speak before the School Board Representative's report; motion passed.

- E. Assembly Report: Christopher Constant Mr. Constant opined that Anchorage's economy and community are on the mend. Recent issues involved zoning in the Upper Hillside and the upcoming April 6, 2021 election. He reported on: Prop 4, a special levy related to police technology; the assembly meetings are streamed at muni.org; public input is being sought on uses of the federal stimulus money; a bill to make the "open meetings act" more effective is moving; and the Anchorage emergency order expires on April 15, 2021.

F. Legislature:

Senator Tom Begich: Senator Begich reported on highlights of senate activities which include: the budget and the difficulties in reaching agreement between the minority and majority; talks on making the education budget separate from the budget; federal funds, up to one billion will be available to state; new COVID-19 variants are



spreading in AK; deeply disturbed that the state does not have an emergency plan/order in place when we may have a high influx of tourists in the summer; Snap

Tristan Walsh-_____ of Representative Fields's office: Ms. Walsh-__reported on the status of HB 121, a childcare tax credit; a bill approving online raffles like the rubber duck derby; a bill seeking to prevent the privatization of some DMV offices in rural communities; a bill for education performance scholarship; and concerns the session will go to 120 days.

- Municipal Planning Department Representatives Tom Davis and Elizabeth Appleby: Presentation regarding the upcoming amendment to the city's zoning ordinance, the Department asking for help tailoring site development - parking, sidewalks, and driveways - proposed change to the one size fits all for parking and driveways.
