# Senator Tom Begich

- Budget Conference Committee meeting, between the House and the Senate, to get the budget on the floor of the House this upcoming week.
  - The Senate has caused delays in the budget. There is a dispute regarding the budget and not overdrawing the earnings reserve. The current dividend looks like \$1,100 – it still needs to be passed by the House and Senate. Discussion on Dividend revenue and constitutionalizing it in upcoming meetings
  - Begich's caucus isn't pleased since requests have been ignored about the American Recovery Plan/ARPA monies of \$500M. Currently not supportive of the budget today. Would like to work on rewriting the dividend formula, amend the dividend constitution, new oil and gas revenue (change barrel tax and/or \$1M property tax, change corporate tax loopholes), and broad discussion of revenue in August.
    - Energy Burden Mapping approved with other small projects
    - Long trail funding \$13.2M
    - Return to Work incentive under discussion on amount
  - Reasonable chance CAPSUS projects identified for Fairview may be supported in final plans/projects.

## **Questions and Comments**

- Karen: The governor changed something where my friend can no longer receive medical services under an out-of-state provider. Could you look into that?
  - Sen. Begich: We will follow up on that. We passed authorization and passed into law, the tele-doc services and the state retiree program will end at the end of June. Unaware of changes.
  - Zack that may have to do with the termination of the disaster declaration, which had the emergency tele-doc authorizations. Will need to figure out the solution with our group. There were a lot of issues when that ended that were not thought about.
- Roger: Taxing of the S-Corps is only for taxing the corps and not the smaller businesses, correct?
  - O Sen. Begich: proposed to only apply to Hilcorp. Has not changed at all, Bill Willowkaskis bill.

- District went well in the capital budget regarding appropriations. Projects on Cordova street, Ingra and Karluk, and coastal trail updates.
- Next week's budget concerns the dividend budget. Will not vote if it overdraws the permanent fund.
  - Not sustainable to draw down the fund
  - o % of the state budget from the dividend
  - Reviewing priorities as a government and a state the 1982 formula
    - Tax pay taxes and receive money back in dividend.
      - income tax on it
    - Impacts middle/upper-middle-class families with double-taxing
- Passed two bills this year -
  - The Able program to help individuals with disabilities
  - o Apprenticeship program labor and commerce bill
  - Recognizing tribes and child welfare statute
  - o Protecting children and adverse experiences bills passed

#### **Presentations**

Providence Health & Services Alaska Community Health Worker Program - Katie Marquette

- Two new programs in four communities, including Fairview
- Community-based programs of the community health worker program and the mobile health clinic
  - o \$77M put into the community
- Community health worker program neighborhood-focused care
  - Each neighborhood has a representative working as a community health worker that lives in the neighborhood. Zabeeba Mohamad is Fairview's representative.
    - offers health education and represents the community as POC for infection outbreaks that happen

- working as POC in case of emergencies
- community building
- health and mental health screenings in Fairview
- Top five areas of focus
  - o COVID-19
  - Mother-Baby Care
  - o Cardiovascular Health
  - Adolescent behavioral health
  - O Diabetes prevention and treatment
- Mobile Clinic services
  - Prevention school physicals, immunizations, and flu shots, health screenings, mood screening, hearing screening, and cervical cancer screening
  - Primary care management of chronic disease, urgent care, behavioral health support, lab services, specialty clinics
  - o mother-baby care prenatal exams, ultrasound clinic, breastfeeding clinics, well-baby checks, mood screenings, and childhood immunizations.

## Questions and comments

- James: Is this the Anchorage health department mobile vaccination clinic?
  - o no, it is different
- Karen: What is the timeline of this getting started and up and running?
  - The mobile clinic currently under construction
  - Community health worker the mobile clinic and health worker, work in tandem, but the health workers will be starting right now. Looking into COVID education and the needs of the community.
- Allen: How long do you think this service will last?
  - Nathan: the intention is for it to last as long as it is promoting good. Secured 2-3 years of funding. This is viewed as a need in the community and approaching as a pilot and bringing in partners.
  - Allen: This is important; to continue to run, it needs participation. It's an important role for members of the community, and all of us should be supporting and promoting it.
  - Chris C: There is a large crowd in front of the rec center during the food banks distribution that would utilize this service. Bring personnel that is language capable because of the diverse crowd.
  - Jenny Jones: Does Zabeeba have people helping her? Is the plan that she finds people congregating in the neighborhood to access people? What is the plan for that community engagement?
    - Becca Valentine: She is one of four community health workers living and working in their own neighborhoods. They plan to work together and help each other out. All the health workers have support from providence staff to help them. They have spent time in many units at the hospital and have robust training. Working on hiring a community health worker RN that helps with assessments and referrals. There will be flyers and electronic media around the neighborhood with information about the program. Also will attend community events. The hope that they will register that she can help and will call her directly.

- Nathan Johnson: This is a grassroots effort; you as the community council, will be the reference. Networking with all other social service providers and organizations in the communities. Would like to help people before they need to go to the hospital. More preventive care
- Karen: Will it be free? Sliding Scale? Insurance?
  - Becca: The services will be free of charge for the community health worker; the mobile clinic will charge insurance if you have it, but it is not mandatory. The primary goal is access, not revenue.
- o Jenny Jones: Thank you! This sounds incredible. We are happy to have you Zabeeba
- Allen: I request that every few months, you attend the FCC meetings and give an update on your program. Thank you for coming
