Fairview Fabrication Lab Presented by Allen Kemplen

- Fabrication labs are getting attention because we are getting ready for the 3rd digital revolution.

Community Comments

 Joanna: I own a B&B in the neighborhood. A person who drives a city taxi disparages our neighborhood and tells people he drops off that the neighborhood that it is very dangerous. Can the FCC bring some defense to the neighborhood? How can we proceed, and what can be done?

- Chris Constant: There is nothing the FCC can do in a legal way. If he is a city/Lyft driver, people can collectively make reviews of this driver and talk down the neighborhood with defamatory remarks. Also, find a way to get positive info about the neighborhood. There is a bias in our neighborhoods.
- Rick: The transportation inspection office. Consumer Protection Act look into that.
