*SFCC voted on Resolution to express concerns over altering SFCC area's voting districts: they have redrawn in ways that do not honor the historical and demographic integrity of the SFCC area.*

SFCC member expressed CEA "double dip on the trail connector. SFCC membership concerned about noise and how the decision from CEA will be made regarding choice to new or old location for building new substation.

**Muldoon Library Report**, Jim Curran.

Increased traffic at the library and they did well with card drive.

**Resolution on Chanshtnu Park**, Yarrow Silvers.

*SFCC voted on SFCC Resolution 2021-4 to keep \$200,000 funding for Chanshtnu Park.*

**Pickle Ball at Scenic Park**, Laurie Ford.

Discussed interest for growing pickle ball players to use the tennis courts at "Scenic Park" location. SFCC will coordinate with Ms. Ford on this for recommendations to Parks and Recreation for modifying the courts.

**State House of Representatives**, Liz Snyder.

Ms. Snyder prefers "Nicole's Map" for redistricting, and supports Chantchnu resolution from SFCC.

**State Senate**, Roger Holland.

Next year constitution convention will dominate discussion. With potential redistricting of District 27 and 28, Mr. Holland will no longer represent SFCC area.
