## **Legislative Reports**

#### Senator Wielechowski

- Passage of Federal infrastructure act. Alaska will be getting billions of dollars in funds; road maintenance and repairs, bridges, marine highway, Encouraged NECC to be ambitious in their wishlist for repairs/requests. This will also create some jobs.
  - Lyn asked if some of the money could be used for the Alaska trail that was put out by the legislature, he was not sure but the trail was/is a priority for him and will look into it.
- Redistricting-he thinks that things in Anchorage look pretty good. There is some controversy in some areas about how they split up Muldoon. The southern half went with Eagle River and other parts went with JBER and/or Government Hill. Anticipating lawsuits regarding the way some of the places were redistricted. Concerns were expressed that some parts of the NECC area are not apart of the Eagle River area.

- Redistricting maps have been finished.
- He has been out in the district asking and hearing about problems in the community. Muldoon elementary school had sidewalks blocked by the snow, taking care of that.

- Last time I mentioned putting an inquiry into the governor and HSS. The letter
  has been received and they are working on it but no response yet. Letter was
  regarding some of the response funds not being distributed or been received yet
  such as food funds (there was a delay with the website). Funding for public
  health nurses in Alaska, funding was there but recruitment has not happened,

- high demand for child care and funding has not been disseminated. She will keep updated.
- New caucus in the legislature that is bi-artisain and both senate/house and pertains to food (economy, production, processing)
- Get the wish list for Bill back better funding. 3.5 billion for water and sanitation
- Will not be representing Stuckagain Heights but will be representing some parts of Nunaka Valley.
- Dave asked if the trail swap would be eligible for money from the infrastructure, she did not know but would look into it. The time frame for that spending is 5 years.

# Representative Spohnholz:

- Redistricting-would have to drive through other two house districts to get between House districts 21 in east Anchorage and 22 in Eagle River
- House Ways and Means committee-did not make a lot of progress, a lot of time spent in Juneau and the Governor changed on a few items.
- Looking for a requesting a review of how the DHHS website was attacked and to prevent it in the future.
- Bipartisan infrastructure-this is significant for Alaska (ports, roads, ferries, internet, water and sanitation), please submit input.
- Healthcare information: pricing is supposed to be listed beforehand or an estimate, if it is not you can file a complaint.
  - Health Care Price Transparency is the law. Penalty for failure to comply is \$100 per day, up to \$10,000 for each violation. If a provider or facility is unwilling to provide an estimate or fails to post the prices of the most commonly performed services, Alaskans should file a complaint AK DHSS at DHSSpricereporting@alaska.gov.

# **Assembly Report:**

### • Assemblyperson Dunbar and Petersen:

- Passed an ordinance to allow boards and commission to meet virtually, boards and commission were having problems meeting quorum.
- First opportunity to vote on the budget will be Tuesday. The new ordinance for reorganization was put out there, which will impact the budget vote due to some of the requests (such as libraries being put in the parks and recreation). Public hearing has been closed, but can still send an email to the assembly for comment.
  - Received the resolution from the NECC regarding money and the parks, they both would like to add an amendment for putting money back on the bond for some of the parks (including Chants Tanu Muldoon Park)
- Bradley Coy is the new traffic engineer, he will also be the one who is doing and approving the traffic calming concerns in Anchorage.
  - Forrest would like put forth an amendment from 500,000 to 1 million for traffic calming, this issue is pertinent to East Anchorage. Still looking for a traffic calming specialist.

- Port Revenue Bonds need to happen so that repair can continue to happen and prevent further damage. These are from fees from their users.
- Also encouraged the joining the board and AMATS
- Sullivan Area continues to have turn over in personnel, the replacement individual (head of human services division) will not need to come before the assembly. There is a warming tent there, however there are 500 people there and technically room for 400, somewhat of a crisis situation. Funding is set through December.
- Bridges at the park are apart of the 5 year plan, Pete or Forrest will add an amendment to the bond so that there is money that goes to park. Steve Rafuse that there is enough money and plans to do the first bridge and will need to wait to see how the bond goes for the second bridge. They are hoping for the bridges like out at West Chester Lagoon (steel and concrete structure that gets paved over).
- There was an amendment that put the chair in charge of the meetings instead of the mayor, mayor vetoed it, assembly is voting on it tomorrow to see if they can override it. Mayor is asserting under the charter he has complete control over the municipal buildings.
