D. Standing Committee Reports:

- 1. FCC Chair Daniel George
 - Thank you to Linda Chase for agreeing to be the FCC Vice-Chair for the rest of the term (through June 2022).

The Executive Committee met and agreed to increase the compensation for the FCC Councils Center staff: Manager up 200/month (from 3,600/month to 3,800/month for ten months a year.) Assistant up 1/hour (from 15/hour to 16/hour) starting in the March $1^{st} - 15^{th}$ pay period.

- 2. FCC Vice Chair Linda Chase Happy to be in the position. Lots to learn.
- **3.** FCC Treasurer Kevin Fimon Presented the January 2022 spending report. Planning to organize the fiscal report with more detail.
- 4. FCC Outreach Al Milspaugh. Assisting councils with Zoom. We need to organize Zoom training – Scenic Foothills CC meeting experienced a racist and pornographic "zoom bomb". Took a while to end it.
- 5. FCC Training Lindsey Hajduk (former Spenard CC president) agreed to organize the FCC training committee. Others volunteers including Bruce Roberts, Silvia Villamedes, Cathy Gleason, and Irene Persson-Gamble.
- Community Councils Center Manager Mark Butler Closed on next Monday February 21st for Presidents Day holiday.

Be aware that the Anchorage School District is allowing use of the schools for community council meetings, but that they require that ASD face-covering and physical distancing policies be enforced at all times.

E. Government Updates (5 minutes each)

1. Office of the Mayor – Uluao "Junior" Aumavae

Mayor Bronson is in Juneau in support of getting funding for the Port of Alaska. Black History month events.

Tongan Relief Initiative.

2. Assembly – Christopher Constant, Vice-Chair

Title 21 and Title 23 changes adopted by a unanimous vote of the Assembly and

with the full support of the administration.

Proposal to create a tax abatement for the construction of Accessory Dwelling Units on hold at this time.

Reapportionment of the Assembly districts continues. Please visit <u>www.reapportionanc.org</u> Proposition 12 that passed in April 202 means that there will be a second "downtown" Assembly member and that therefore the downtown district will have to grow to a size equal to all the other five districts. There will need to be significant changes to the existing Assembly district lines in order to make this happen. After considering many map versions, there are three maps under consideration by the Assembly. There will be a public meeting on Thursday February 24th at 6 pm at the Loussac Library, followed by an Assembly work session on Friday February 25th and then consideration by the full Assembly at the regularly scheduled Assembly meeting on Tuesday March 1st. New maps or variations of the three finalist maps may be introduced at the Assembly meeting. Once a new map is chosen, there will need to be an election to fill the "12th" seat within ninety days.

3. Anchorage School Board – Dora Wilson, School Board member Contract with teachers now in front of the teachers for approval. Search for a new superintendent continues with a February 21st deadline for applicants. Spring lottery closing March 17th. Two-year bond on the April 2022 ballot with 38 different school projects.

The Seward Glenn Mobility PEL Linkage Study is looking for input from residents, businesses and other organizations to determine which problems need to be solved in this part of Anchorage. It is the "scoping" phase of what was previously called the "Highway to Highway" project that would better connect the Seward Highway to the Glenn Highway, in a way that compliments the best of each neighborhood. Mountain View CC – State redistricting (want Davis Park included in the Mountain View district)
