 - o Josie W Yes, please let me know if I could do better interfacing with the groups.
- Chris C Probably a good idea to add on the mailer that information is available in many other languages at a URL.
- James T Are you planning on sending more mailers to the Fairview neighborhood?
 - Josie W public meetings will have postcards, newsletters were mailed to everyone for the first one, and others will be on the existing list. Sign up if you want to be on the list.
- James T Are they in other languages?
 - Josie W yes and no, but we provide info in different languages on how to access it in another language.
- James T It would be good to make a better design, so people don't throw it away. It may be good not only to track cell phones since not everyone uses cells. We want to see the pedestrian traffic.
 - Josie W Please place that as a comment via email to formalize. John M Regarding the cell data, I believe there may be data available based on the speed and location.
- Mackenzi How specific are you looking for regarding problems? What level is most helpful?
 - o Josie W we will take anything you want to tell us. The more specific you can be, the better.
- Jim T In the last virtual meeting, there was another meeting that went on the website. There was no date or access information.

- Josie W There are no public meetings before the deadline. Do you need another public meeting?
- Linsey I noticed some of the comments on the map include people's names, though I thought it was anonymous once posted (though you could see the submitter on the back end). Is that an error, or am I wrong?
 - o Josie W I will check on that. Info should not be shown. Personal info should not be displayed.
- Allen I notice that the study is promoted as a transportation study. Very broad, but as you went through, the tech studies were about vehicles. Is there a reason why there is no analysis on pedestrians, bicycles, and other modes and appears to only focus on vehicles?
 - Josie M the next report will be about pedestrians and bikes. In the past, it came from the metro transportation plan - problems related to congestion of vehicles and safety.
