I. Called to Order at 7:03 PM via Zoom

- 1. **Approval of Agenda**: A motion was made and seconded to amend the agenda to replace item 1. Old Business Inlet View School Traffic Study report by Brad Coy with Transportation report from Cheryl Richardson; motion approved.
- 2. **Approval of Minutes**: A motion was made and seconded to approve the March 24, 2022, minutes as submitted; motion approved.

II. Reports

A. Legislature:

- Senator Tom Begich spoke to the status of the budget and his priorities. These include the Food Bank, school maintenance and forward funding of education. He reported on the status of funding for and development of the "Long Trail", comparing the concept to the 2,200 mile long Appalachian Trail between Georgia and Maine. A Q&A followed. Senator Begich stated the session could be done by the end of May. A Q&A ensued regarding traffic corridors and traffic calming in the neighborhood. The new DOT Commissioner, Ryan Anderson, P.E., seems, to Sen. Begich, to be responsive to the neighborhood's needs and concerns.
- Representative Zack Fields: No report.
- B. **Mayor's Office:** Terrence Shanigan reported the temporary housing at the Sullivan Arena will close in June 2022.
- C. **Assemblyman Constant:** No report; Assemblyman Constance was attending a Special Municipality Assembly meeting.

- E. **ASD Board Representative:** Margo Bellamy, Board President, reported on ASD year-end activities including in-person graduations, first in two years, which will be held at the Alaska Center. The new ASD Superintendent, Dr. Jharrett Bryantt, begins onboarding May 16th. ASD will hold community engagements to meet Dr. Bryantt. The Calendar Committee has posted two calendar surveys for community input. Next step re the failure of the school bonds, including South Addition's neighborhood elementary school, Inlet View, is to debrief staff and the board.
