A Candidate for Municipal office must be a resident of the Municipality of Anchorage, and

a qualified voter of the Municipality of Anchorage and the State of Alaska, among other specific qualifications.

There are very specific steps you must take to appear on the Regular Municipal Election ballot as a candidate for office.
