6b. Proposition 6. Roger Marks. State Park Access Glen Alps

Background: Muni can't bond for improvements in RSA. Can't afford capital improvements. Most traffic is park traffic, not local residents. Roads are in bad shape. Upper Dearmoun was last paved in 1987. Proposition creates service areas. Then would allow muni to submit bond packages to voters for improvement on road improvements on park access roads. Would also allow federal grants.

Q. Would Proposition change how design is handled?

A, Design would go through Public Works.
