Information about Zoom

At the March 2020 General Membership Meeting, there was a discussion about moving to a different method for future meetings because of the importance of avoiding gatherings during this time of COVID-19, and an ad hoc committee was created to explore options. The Fairview Recreation Center was closed the next day. Subsequently, the ad hoc committee recommended using a virtual meeting interface application called Zoom.

Zoom is used quite a bit in business settings and is relatively user-friendly. It can be used on smartphones, tablets, laptops, and desktops. But it has its limitations with respect to bandwidth. In ordinary times, it is possible to see the faces of other meeting participants (assuming everyone has a webcam). Still, given the recent massive increase in the use of the internet, the guidance has changed, so we ask meeting participants to do the following:

- Do not use your video camera
- Make sure your microphone is muted

These will be the default settings when you join the meeting, so don't worry if you're unsure how to do this.

Also, we will be using the chat box feature in Zoom to ask questions and make comments, although if anyone wants to speak, they can request this in the chatbox and will then be "unmuted." In virtual meetings, this is the equivalent of raising your hand and being recognized by the chair.
