6:40pm Update from Firestation 7

- Bond approval will provide new ambulances.
- Pulse point is an app. If you are CPR trained, it will alert you if you are within half mile of a cardiac arrest. Won't alert within home, but will alert for public spaces.

6:47pm - 6:54 Senator Claman Update

- Question from Robert Hayes. Asked about concerns for transgender and homosexual books in schools. Rep. Claman shared he doesn't expect it to get on the floor as it is divisive.
- Results from constituent survey from Matt Claman. Over 60% of community gave government budget a D or F. Spending priorities and raising revenue pretty mixed. 70% support using revenue to pay for increase dividend. 60% support returning state retirement to pension structure.

- Bill that would make it a crime to commit an assault in the presence of a child.
- Bill that gives human rights commission over non profits, excluding religious institutions.
- Traditional Pension Bill. Currently stuck in the house.

- He shared he thinks House Bill 105 is struggling despite having its supporters.

7:25pm - 8:31pm Discussion on AS&G Project

Frank Rast shared a resolution 2023-01 that AS&G does not fill above 162, and permit is extended by 5 years only to May 2029.

Ryan Zins VP and General Manager of AS&G and Ryan Morman VP of Operations present. Fill site is clean fill. They have been there since the 40s. Issue is Anchorage has poor soil so it's hard to build. Kincaid has a lot of fill that needs to be removed because of drainage issue. If you don't have a fill site in your area, you have to take it to valley or other expensive legal sites.

CUP is conditional use permit which came in 83. You have to go back every 5 years after filling to discuss.

- · Getting municipal water for 26 homes on wells
- Opposition to de-icing aircraft near the neighborhoods
- A proper noise study done on the area.

Identified 147 wells near airport. 90-95 wells were tested since last Fall. Some people did not want tests and some didn't responded.

Two wells and one in Spenard/Lakehood had a little bit of PFAS/PFOB detected. Homes have requested funding from municipality as a capital improvement project.
