- NECC's resolution on Boundary Trail, SFCC is not going to adopt a similar resolution. SFCC has already passed a resolution, years ago, in favor of the perimeter trail along the East Side of Scenic Foothills.

7:15 - Neighbor Concerns

- Spring Cleanup, we need to find a volunteer coordinator for bags and information. We should appoint one at the next meeting.
- CC boundaries planning-Care Cliff, is on the board, though she was out travelling during this meeting and could not report. She did attend the introductory meeting this past Monday and a number of good ideas have been brought up. There have been suggestions that NECC be reduced and SFCC be expanded northward. But this is very early in the discussion.
- Fire Hydrants. Patrick LeMay mentioned that the hydrants have been covered by snow and suggested that residents attempt to spot their hydrants and if necessary arrange for them to be dug out. This is a human life safety issue.

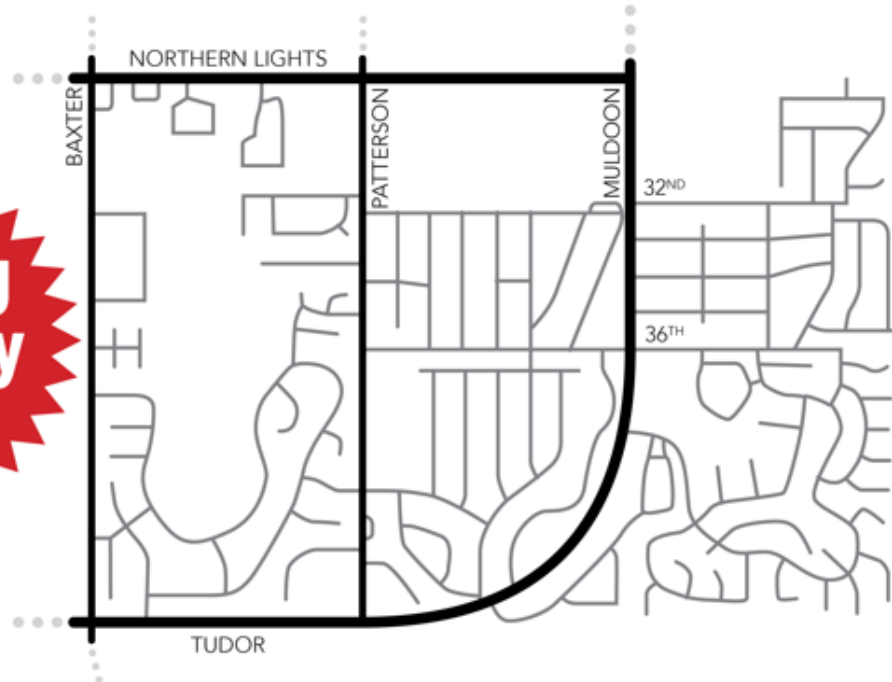
