- Averages 2-3 fatal fires a year.
- They have their own sewing team to repair their own materials.
- \$108,000 raised by fill the boot by the City of Anchorage last year.

- The house passed budget over to the senate. It was a deficit budget with a 50/50 dividend.

- · Identify goals and objectives of using time and money responsibly.
- Collection of inventory. Meet with various tenants and airlines to see what assets they have and what they will need in future.
- Forcecast is meeting with airline and getting a handle on what to expect with regards to their operations in the next 20 years. What will growth be like?

Currently finalizing the inventory and kicking off forecasting. Airline advisory committee and working group committee and Sand Lake Community Council along with two other community councils are a part of the working group. First meeting scheduled tentatively for May 31st in the afternoon and then a public open house that same evening.
