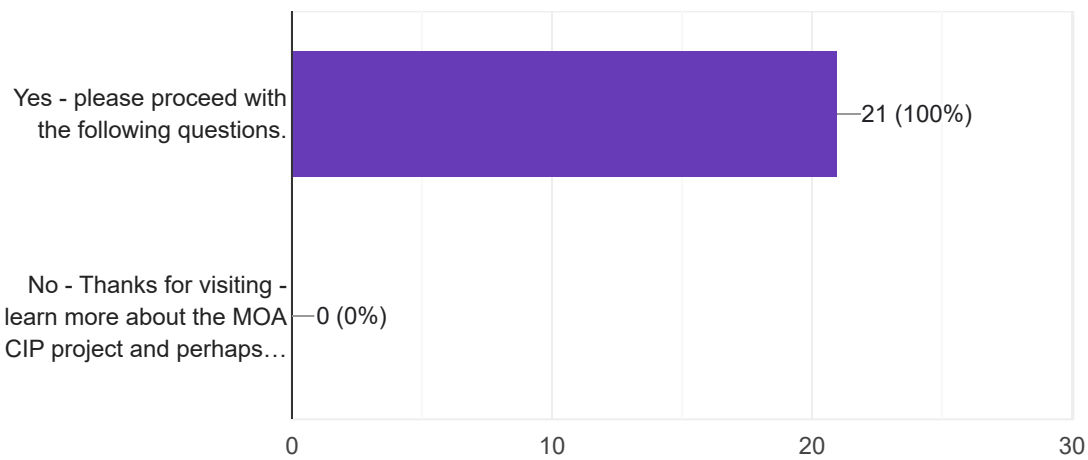

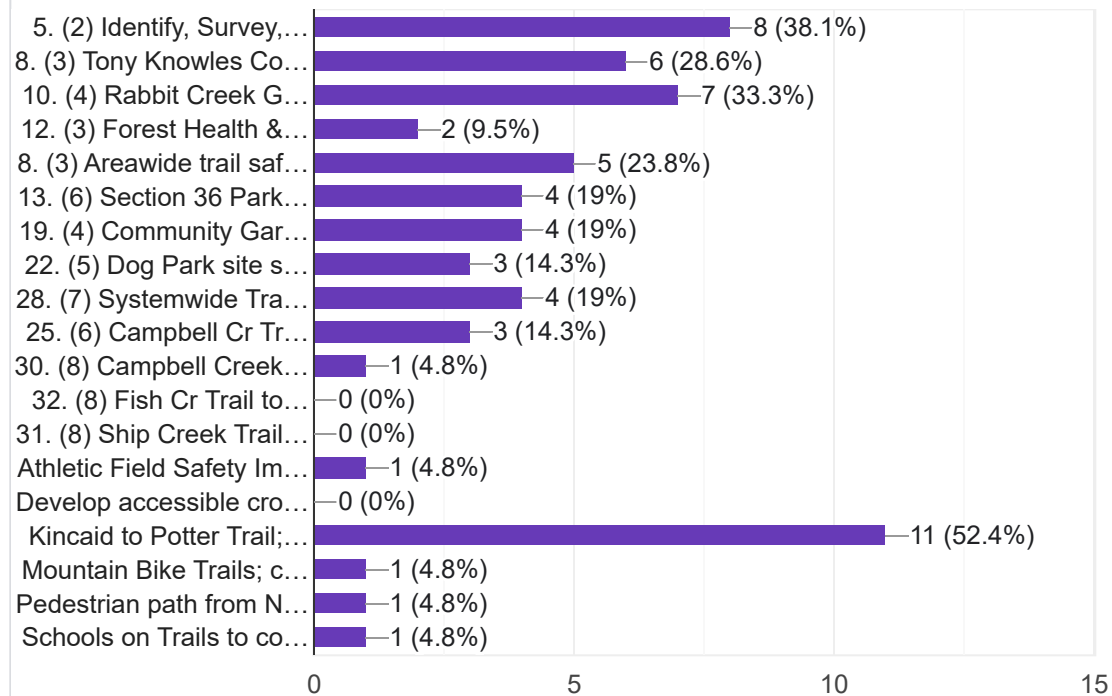

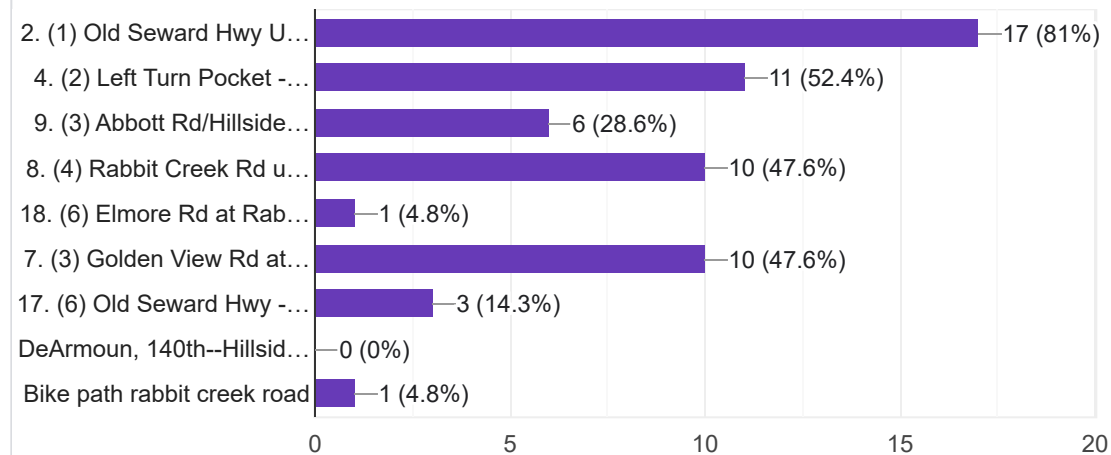
Interested in exploring the feasibility and cost of providing access to Snowshoe Park. Thanks!

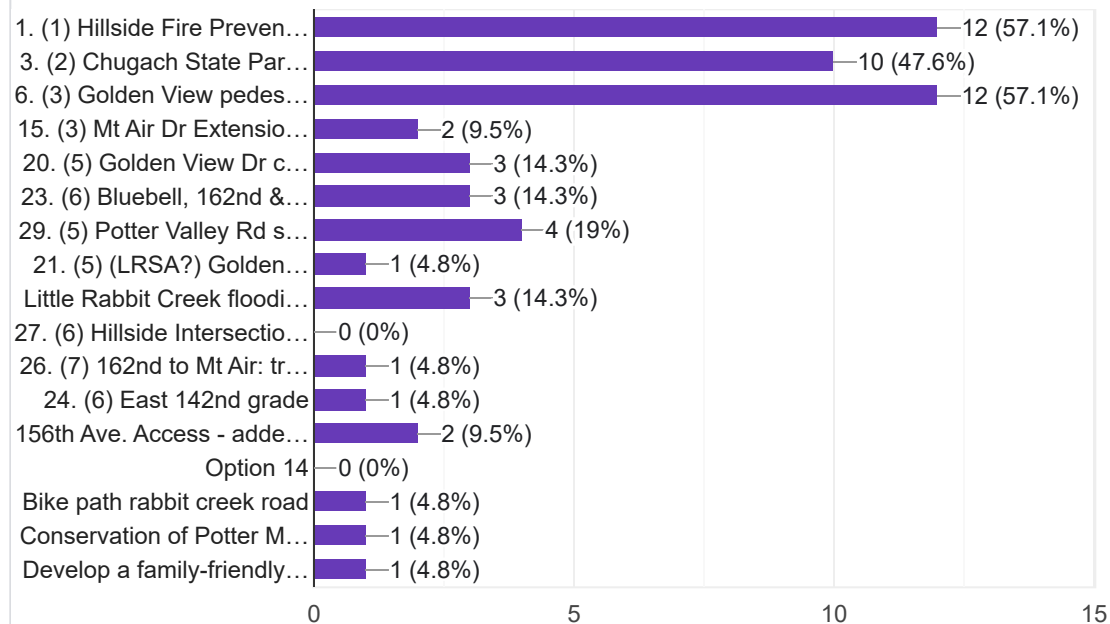
Improvements to the Old Seward highway between Rabbit Creek Road and Potter Valley Road including a pedestrian/bike lane or sidewalk and including speed-reducing humps is pertinent to the safety of residents and visitors to this roadway. Traffic and pedestrian usage continues to increase on this road and the current shoulder does not allow pedestrians to safely be out of harm's way. With improvements to the road surface planned, it will become even more pertinent that safety measures take place, as vehicle speeds will certainly increase with a smoother roadway. Please consider adding a bike lane or pedestrian pathway to this road, as well as consideration of speed-reducing humps when planning construction for this highway.
