Board Roll Call

<u>Minutes Approval: May</u> - One change needs to be updated under Anchorage Public Transit - the total project needs to be updated to \$500,000. **Bob Reupke motions, Selina Metoyer seconds.**

<u>Treasurer's Update</u> - Lyn Franks reports \$2074.68 but there are outstanding checks for the picnic.

FCC Report

Bob Reupke: No FCC meeting this month. Reminded people that they should attend the farmer's market. Community Concerns and Activities (opportunity for community members to share concerns, requests for the council, and upcoming needs/activities, 2 min each).

- Selina apologized for any misunderstanding or offense in the officer's meeting
- Why is the Holiday closing at E. 20th? Nobody knew
- Stu complained about Muldoon and E 11th being a complete mess with lots of trash and tents.
 Centennial now has illegal tents but also renters enjoying the campground. Send letters of complaints.
- The bridge is in by the dog park at Chanshtnu Muldoon Park and the rent-a-cans are in bad shape
- Selina attended the transit meeting and it appears to improve all routes, so positive changes.
- Stu says that shopping carts are flooding the parks. Irene Boll wants to help pick them up and return them

Legislative Reports (limit 3 min. each, including guestions)

David Dunsmore, Office of Sen. Wielechowski: The session ended and the budget passed. Largest school funding ever. Reach out to the Gov asking him to support it. Big push next session: community solar and renewable projects bill. Alaska work safe: auto payroll deductions for 401ks.

Corey Alt, Office of Rep. Mears: Corey.Alt@Alaska.Gov 510.599.3893 on Zoom for Rep Mears reported getting organized for the next session. Topics: food security. Working on reports and refining them.

Assembly Reports (limit 3 min. each, including questions)

George Martinez: Homelessness committee still has Centennial on their "plan"

- Lots of planning going on, but some things like the pallet houses will need a title and code change

- Hickel's lawsuit is still being hashed out lots of discussion about how long he has been working in this city, how they used Muni gasoline and that everything that happened with this project was devoid of business as usual. George encouraged the public to speak up.
- Zoning changes are being worked on for R4 which is multi-family like 4-plexes. It would allow for some "in-fill" housing, like tiny houses.
- Stu asked about how many stabbings and the shooting happened at Centennial last year George asked him to confirm that with Steve Rafuse and to CC him.
- George is looking at starting a chamber business group for Muldoon

<u>Community Leadership Updates as available</u> (3 min each) <u>JBER</u>, <u>Mayor's Office</u>, <u>Police Department</u>, <u>Fire Department</u>, <u>Parks & Recreation</u>, <u>Muldoon Public Library</u>, <u>School Board</u>, Community Patrol, others.

Kelly Lessens, School Board: Governor received the budget with one time funding for \$49 million for upcoming school year to help cover the 80-90 million deficit. Community request: please urge him to support the base student allocation. 2023-2024 calendar revisions coming. Increase for paid meals as well, not for those that do not pay. Policy revision requiring 60 minutes of fentanyl education. There was a surge in health related claims and cost of healthcare in the last year so money was moved around. DOD funding of 80% and ASD 20% for Ursa Major school on JBER - good news! Summer schools have started. Later start times are coming so watch for that. Kelly is moving to another CC as board members move around throughout the year, but it is unknown who will attend NECC.

Centennial Park Open Discussion

Centennial Park Discussion - George notes that it has been removed as an option and should never be an option as there is no controlling a site in the woods in a humanitarian way. We need "right sized" permanent housing so looking at existing housing, treatment beds and beds for lower barriers. Looking at taking bad places and turning them back into housing with incentives - some of which are owned by banks and bad owners. Northway Mall is not an option as the city should not warehouse people. We all have a stake in this so should get involved. Kevin from Eagle River is involved, and ER is very NIMBY (not in my back yard) and very outspoken. Bill Oakes complained about the homeless moving behind Walmart.

Meeting Space Location- Ron Meehan

- Meeting space. Jamie is in-touch with CITC about their new Fab Lab next to Krispy Kreme, across from Fred Meyer. They are just opening and will discuss further around August. No changes in location at this time. Tabitha Toloft and LeAnne Garrick are the contacts. George pointed out that he just toured the location and it's high tech and excellent, and would fit our needs perfectly.

Overnight Parking Ban Resolution

I am strongly opposed to the parking ban. I know in Nunaka Valley many people park on streets while working in yards or driveways. My driveway only holds one car which is true for many homes in my neighborhood. The condos off Pembroke only have room for one car. If a person is entertaining their guests would have no where to park. The ball fields in Nunaka do not have enough parking for families if there is a big event. During school events at Nunaka Valley parents park all around the school on the streets. Many people stage the RVS in the streets before going camping.

I am not sure why the resolution implies there is enough in the area. If families want to go to Nunaka Valley North there is very little parking unless the people park in the Church Parking lot. There is no parking if entering park from Atkinson Drive.

The municipality does not enforce laws on books already. It takes weeks to get an abandon car removed. The municipality can't keep up with crimes taking place in our neighborhoods. Where would enforcement of this resolution fall in their priorities?

If this resolution moves on to assembly I will loudly speak against it. I have walked these neighborhood street multiple times day for 36 years, I have not felt unsafe at any time.
