**I-III. Call to order, approval of agenda, and approval of minutes**

Chair Harary called the meeting to order at 7:01 pm. The agenda was approved as amended. The draft minutes were approved as submitted.

**IV. Old Business**

a. Council members discussed alternatives to daylight saving time. A legislator with an interest in this issue is Dan Ortiz, Representative. Dan.Ortiz@akleg.gov.

**V. New Business**

- a. Kevin Fimon asked what could be done about the unsecured, derelict school bus parked on the former daycare and church property behind Bread & Brew. Bus windows are broken and people are living in the bus. Children are visiting the site. Assembly member Zalatel suggested reporting via AnchorWorks and contacting Muni to report a code violation. The property is owned by the Alaska Seventh Day Adventist corporation.
- b. Tricia Kunnunen publicly thanked Felix Rivera, not at the meeting, for his assistance in resolving a municipal matter. She also requested guidance on having Muni move a "no motor vehicles" signs, currently obscured among trees, to prominent positions at each end of the Petersburg Path, between Petersburg and East 56<sup>th</sup> Ave. Motorcycles are using this unpaved path, where children play. Members discussed AWWU failure to repair non-functioning fire hydrants when AWWU finds working hydrants in the area.

**VI. Reports**

a. **FCC Kevin Fimon.** FCC officers are working on the hiring process for a new FCC manager. The annual picnic, scheduled for July, was canceled. The FCC offices are closed for most of the month of August due to staff vacation. Kevin's term as an FCC officer has ended.

b. **Housing and Homelessness Committee** In Michael Burke's absence, Tony Andrew reported. He suggested establishment of a sanctioned, dry campground at the Tudor & Elmore location. He noted an effort to identify potential sites for homeless shelters in each community council area.

**Rep. Andrew Gray** The governor signed his bill to require the Department of Corrections to provide photo identification to each prisoner upon release from incarceration. A revised reversion of the proposal to limit

**Rep. Andy Josephson** Alexander Schroeder reported on pending bills and recent activities for Rep. Josephson, who was in Dutch Harbor.

Good morning all,

On 28 August, we will be replacing iSportsman with a new recreation access system called RecAccess. This new system goes live on 28 August.

Registered users are encouraged to update the email address associated with their iSportsman account by 17 August to minimize disruption and ensure a seamless transition.

Mobile phone accessibility, displaying users' present whereabouts within recreation areas, and checking out of these sites via SMS text messaging are all RecAccess features and benefits.

Users will receive instructions on generating a new RecAccess password and login through the email address associated with their iSportsman accounts.

Current permit holders will not be required to repurchase licenses for 2023 and will be transferred to RecAccess using the email address linked with iSportsman.
