5. <u>Assembly Update</u>: Chris Constant discusses numerous issues relating to housing and homelessness. Mentioned the protective bike lane project. Noted discussion of change of name of the Port of Alaska to the Don Young Port of Anchorage. Discussed further work to be done on ordinance re zoning practices. Discussed the Eklutna River Restoration project. Much discussion of steps to be taken to deal with the homelessness issue this coming winter. Reported that Tract J has been dedicated as a park. Also discussed Bear designation efforts to have bear resistant trash containers provided.

6. <u>JBER</u>: Joy Boston discussed the AIM High Flight Academy (apply by October 15) and the new ReAccess pass that is replacing iSportsman.

AIM High Flight Academy

This is an opportunity for high school students age 16-18 to attend a 3-week flight introduction program that includes up to 15 hours of flight instruction. RecAccess has replaced iSportsman as the web platform to safely recreate on military lands.

RecAccess features (new):

- smart phone friendly

- sign-in/sign-out of training areas via SMS (text)

- increased recreation area access; check-in to 3 areas (this is an increase from 2 with iSportsman)

9. Anchorage School Board—Dave Donley summarized the school board's 3 main goals. Noted additional school closures will likely be necessary but that it will be an "open process" without targeting specific school(s) at the outset. ASD faces a significant \$95 million budget deficit. To just meet the deficit would require laying off 500 employees. Miles Baker inquired as to the "academy model" which has been discussed. Chris Sis inquired as to future status of the immersion program at Government Hill Elementary School.

10. New Business: A. North Point Bluff Viewshed Resolution: Steve Leider presented the proposal and the history of resolution for vegetation management including removing cotton woods etc and adding native vegetation. Work to be done through donations and volunteer work parties. Jody Sola reads the resolution. Miles Baker reports concern of individual property owners pursuing "self-help" to take down trees as opposed to this resolution following the proper procedure.

C. Jody Sola raises the request by Abraham Gallo to purchase the Municipal parcel near Ski and Benny's and where espresso stand is located. Concern raised about access to the school and that the sale of the parcel would not be consistent with the adopted neighborhood plan or the terms of the sale of the property to the Municipality by the Alaska Railroad.

Stephanie Kesler moves that GHCC endorse a letter objected to sale of the parcel. **Second**: Peter Murphy

Motion passes by unanimous voice vote.

11. Old Business: Jody Sola reviews the history of Tract J

12. Other matters of community interest: General discussion of the proposed improvement of Whitney Road near the Port and possible impacts on the neighborhood during construction.

Noted there will be a cyclocross race along Harvard Avenue of September 30.
