Mayor's Report: Mayor Dave Bronson gave updates on many local issues including the Port of Anchorage, efforts around homelessness, a new agreement with Eklutna in Eagle River, snow plowing and the police department. Mayor Bronson opened the floor for Q and A and answered member questions directly.

Alaska Legislative reports:

-Senator Elvi Gray-Jackson - please see attached written report

-Representative Alyse Galvin - She gave an update to her recent activities and listed her priorities for the legislative session: education, defined benefits for employee retirement and

revenue measures that make sense for Alaska (long-term fiscal planning). Other concerns include DOT, the State and the Muni need to work together.

Assembly reports:

Meg Zaletel - January is an important month because they take up bond and ballot measures. Ms. Zaletel gave an overview of the bonds, including road and storm drain capital improvements, public transit and safety improvement, and the Anchorage Goes Bond.

Felix Rivera - Mr. Rivera gave an update about body worn cameras, 100 out of 350 have been deployed already with 2-4 body cameras installed and deployed each work day. He also gave updates around homelessness, the emergency cold weather shelter system and the efforts to focus on transition out of the emergency cold weather shelter so we don't have what happened last summer happen again this coming summer.

School Board Report:

Carl Jacobs - The Board is focused on grades 3-5 math proficiency through the Map Testing, they want to partner with law makers who want to fund education in a meaningful way to support our students and to attract and retain educators. The board will be voting on a new policy that would grant the PTA a position on the Board. And he gave an overview of the school board bond.

Committee reports:

Transportation - David Evans was hoping to have an update on the Fireweed Lane project, but the contact is out of town. Hopefully he'll have an update next month.
