A RESOLUTION RECOGNIZING THE FAIRVIEW COMMUNITY COUNCIL

WHEREAS, the Municipality of Anchorage, having adopted an Ordinance authorizing the recognition of Community Councils; and

WHEREAS, the Fairview Community Council, having petitioned the Anchorage Assembly for official recognition; and

WHEREAS, having received a request to recognize the formation of the Fairview Community Council which includes that geographic area encompassed as follows: beginning with C Street on the west, north to Ninth Avenue; east on Ninth Avenue to Cordova; north on Cordova to Second Avenue; east on Second Avenue to Merrill Field; south on Merrill Field to Chester Creek; west to Seward Highway; south on Seward Highway to Fireweed; west on Fireweed to C Street; and

WHEREAS, this Council has a policy and practice of open membership which encourages participation of persons from all segments of the community; and

WHEREAS, this Council does not charge dues or require other financial contribution as a condition of membership or participation in excess of \$5.00 per member per year; and

WHEREAS, this Council is representative of the residents in the district; and

WHEREAS, this Council has held at least two well publicized meetings in the district which resulted in determination to seek recognition as a Community Council;

NOW, THEREFORE, BE IT RESOLVED by the Anchorage Assembly to hereby officially recognize the Fairview Community Council as an authorized Community Council with all of the functions and responsibilities thereof.

RESOLUTION
RECOGNITION OF THE FAIRVIEW COMMUNITY COUNCIL

We, the residents of the Fairview community, formally request recognition by the Anchorage Municipality Assembly of the Fairview Community Council as provided under Municipal Ordinance Number 74-163.

The Fairview Community Council is a non-profit, voluntary, self-governing association composed of residents, property owners, business owners, and representatives from non-profit associations located within that geographical area designated by this Assembly as Fairview.

Over a period of (3) three months, organized meetings took place in the Fairview community. An organizational constitution was developed during this period, and is attached as Exhibit I. This constitution defined the boundaries of the Fairview Council Membership. This constitution established a policy of open membership in the community seeking full participation of persons from all segments of Fairview.

On January 8, 1976, an election of officers took place resulting in the election of those officers listed in Exhibit II. The Fairview Community Council has conducted business meetings for the past months of 1976, and now presents this resolution and exhibits for consideration and recognition by the Anchorage Municipality Assembly.
