Order Form and Invoice

The Society of American Foresters—Cook Inlet Chapter will hold its annual Arbor Day tree seedling sale on Saturday May 9, 2009 in the parking lot on W. Northern Lights Blvd and Spenard Road, near R.E.I. starting at 9 am. Seedlings ordered using this online form will be reserved from the public sale and distributed on May 9, 2009.

Seedlings will be packaged in bundles of 20, approximately 8 inches tall (most species), and wrapped in plastic.

Cost is \$20 per bundle of twenty (20). To help ensure that your pre-order is filled, this form with full payment must be postmarked by May 1, 2009* and received at Cook Inlet Chapter's P.O. Box (address below). Your order will be filled and set aside the morning of our public tree seedling sale. Pre-ordered seedlings not picked up by 2 pm on May 9th will be sold at the public seedling sale.
