### March 15, 2012 MINUTES

**APPROVAL OF AGENDA AND FEBRUARY MINUTES:** Meeting was called to order by Vice-President Barbara Karl at 7:03. There was not a guorum for approval of the agenda or minutes.

TREASURER'S REPORT: \$101.59 in bank account

**LEGISLATIVE REPORT:** No report.

**ASSEMBLY REPORT:** Sheffield Contract - \$60,000 - postponed indefinitely. Anchorage School District Budget was introduced at March 13<sup>th</sup> meeting. Proposed budget is \$726,842,354. \$239,963,319 in property taxes. Public Hearing will be March 27<sup>th</sup> after 6:00 p.m. in the Assembly Chambers. Assembly Members Drummond and Gray-Jackson introduced an ordinance to adopt Title 21 amendments proposed by the Administration to give final approval on provisionally adopted sections with no further review by the Planning and Zoning Commission. Public hearing was requested on March 27<sup>th</sup>. Chair Ossiander was successful in moving the Public Hearing to 6/5/13. Travelled to D.C. and met with Senator Begich who was successful in the securing the Senate's passage of a two-year Transportation Bill which includes 1 Billion Statewide.

**PTA REPORT:** No report.

**PARKS COMMITTEE:** There will be a park clean up day at Sitka Park on June 30.

**TRAFFIC COMMITTEE:** Becky Kurtz brought up the dangerous curves on Sunrise between E. 16-18 avenues. There have been several accidents in that specific area this winter. It may possible to be put on the CIP list for improvements that would slow down the traffic whether it be stop signs and/or "speed bumps". This option should be researched.

FCC REPORT: None

**ANCHORAGE TOMORROW**: Todd Jacobson presented Propositions 2, 3, and 4. Proposition 2 concerns the rehabilitation of the road between the Northway Mall and Penland Park. Prop. 3 concerns (in part) making the Cuddy Park handicap accessible. It also contains funding for other area park projects. Prop. 4 concerns transportation needs. **PROPOSITION 1**: Jeff Friedman presented Proposition 1 which concerns money for a design to update Airport Heights School along with funding for Service High and other maintenance issues for ASD.

**TITLE 21:** Barbara Karl updated the Airport Height Community Council resolution concerning proposed changes to the Provisionally Adopted Title 21. John Whitlock, AHCC Zoning Committee Chair, has been working on this and keeps us updated. There was no quorum so we could not vote to accept or reject the proposed changes. The Executive Board will meet to work on the resolution.

ADJOURN: Meeting was adjourned at 9:00 pm.
