Meeting Minutes for June 16, 2013

Meeting Start 7:00 PM

President's Report:

Update on parking and traffic along Delaney Park Strip - Easy Park patrols north side of 10th Ave. along the park strip and Anchorage Police Department patrols south side of 10th Ave. along the park strip. If there is illegal parking along the south side of 10th Avenue, call the municipal traffic hotline @ 786-8949.

Coastal Trail Repaving should be done by August.

Treasurer's Report: \$3135.62.

Fire Department: Captain Brian Parch spoke about losing the second ambulance to the Spenard Fire Station as the renovated fire station has been completed. He passed out literature regarding fire stations and fire fighters. Also, he added that the burn ban is in full affect (June), until otherwise noted. This means the only outdoor "fire" on can have is for cooking on a BB-Q grill - nothing else, or you could be subjected to a \$500.00 dollar fine.

Representative Les Gara - reported that the oil tax debate with Governor Parnell was on-going. There is a movement to repeal the oil tax and it looks like there's going to be enough signatures to get a repeal on the ballot. Representative Gara is working steadily to get laptops for donations to school age kids who are in foster care.

Business:

Disc Golf: Darrin Huycke discussed the ongoing efforts to development a management plan for Disc Golf to continue year round along the Westchester Lagoon. Currently the Disc Golf can only be used in winter and not in summer. There are two issues: (1) the environment, and (2) overuse of the park. Overuse was damaging the park and surrounding area and the Disc Golf was attracting noise, litter and drinking. There were two golf poles that were in direct conflict with the bike path, which also caused summertime problems. Solutions to this could be not using those poles in the summer, volunteers could patrol and place clear signs with rules. Parking, trash and illegal activities would not be tolerated, especially since Westchester Lagoon sports a family atmosphere. Look for more to come regarding disc golf for summer time usage in the future.

Parks and Recreation: MOA Scott O'Brien stated that the goal is not to have more than two events at the same time along the Delaney park strip. He stated that he would work with Shane Locke at MOA traffic management to fix the pedestrian problems during events at the park strip.
