• Email from neighbor-Reporting about possible homeless people in the area of Scalero Circle/72nd Street.   - Quick update from the administration regarding the drainage issue in the Spruce Brook, Little Brook, etc area. "At this point, our position would best be described as monitoring. As Kenna noted, we have not observed stormwater leaving the right of way drainage system and entering private property. We installed

updated drainage features this past August. We will continue to monitor the location. If we determine that stormwater from a municipal system is entering private property, we will take additional action to correct that situation." At this point, I would suggest that any neighbors with specific issues document those and share those with the council and elected representatives so we can work with the appropriate offices.
